3 MS. FLETCHER: Would the parties in the
4 matter of Green Island Café, Heaven and Hell
5 please come forward? This is Case No. 15-PRO-
6 00102. Green Island Heaven and Hell, Inc.,
7 trading as Green Island Café, Heaven and Hell,
8 2327 18th Street Northwest. License Number ABRA
9 074503. This is a Retailer Class CP, substantial
10 change, summer garden with 40 seats.

11 The protest issues are adverse impact on
12 peace, order, and quiet. My name is Laverne
13 Fletcher and I'm conducting the roll call hearing
14 as the Board's agent, pursuant to D.C. Official
15 Code 1601.2.

16 Introduction is beginning with the
17 applicant. Is Mr. Woldemariam present? Present
18 on behalf of the Kalorama Citizen's Association.

19 MR. JAMES: Yes. Denis James, President
20 of Kalorama Citizens.

21 MS. FLETCHER: Mr. James, Denis spelled
22 with one N?

1 MR. JAMES: Yes, that's correct.

2 MS. FLETCHER: And J-A-M-E-S?

3 MR. JAMES: That's right.

4 MS. FLETCHER: Thank you. And present on
5 behalf of ANC 1C?

6 MR. SIMPSON: William Simpson, Chair of

14 MS. WILLIAMS: That's correct.

15 MS. FLETCHER: And so, Mr. Simpson,
16 you've got your little fellow with you, huh?

17 MR. SIMPSON: Yeah.

18 MS. FLETCHER: Oh, he's so cute.

19 MR. SIMPSON: He wants to protest too.

20 MS. FLETCHER: Do you want to introduce
21 him for the record?

1 MS. FLETCHER: The Kalorama Citizen's
2 Association, ANC 1C, and the Group of Seven do
3 have standing as protestants. The representative
4 from Heaven and Hell, Green Island Café and
5 Heaven and Hell is not present. The application
6 is dismissed and the Board will issue an order
7 dismissing the application and you'll get a copy
8 of it and the applicant has 10 days to seek
9 reinstatement. And you get to respond to that.

10 But the application is dismissed.
