AGENT FLETCHER: Thanks you. If you would please come forward.

Is the -- before you do that, is anyone present from ANC 1A?

Okay, if you would just wait one more moment, I'll call your case again in a minute.

Are the parties present for the Good Guys Restaurant? Is ANC 3B present, as well?

PARTICIPANT: Yes.

AGENT FLETCHER: Okay, if you would please come forward. Excuse me, I've got something in my eye. One second, please. Give me one minute.

Okay, introductions, beginning with the Applicant, please.

MR. KLEIN: Good morning. Andrew Klein on behalf of the Applicant.

MR. ZANGANEH: Behnam Zanganeh,

1 the owner of the Good Guys Restaurant.

2 AGENT FLETCHER: Thank you, and
3 would you please spell your name for the Court
4 Reporter?

5 MR. ZANGANEH: B-E-H-N-A-M, Z-A-N-
6 G-A-N-E-H.

7 AGENT FLETCHER: Z-A-N-G?

8 MR. ZANGANEH: Z as zebra, A-N-G-
9 A-N-E-H.

10 AGENT FLETCHER: Thank you very
11 much, and present on behalf of ANC 3B?

12 MS. BLUMENTHAL: I'm Jackie
13 Blumenthal, B-L-U-M-E-N-T-H-A-L.

14 AGENT FLETCHER: Thank you, Ms.
15 Blumenthal. ANC 3B does have standing as a
16 protestant.

17 This is Case No. 13-PRO-00157,
18 3124 Corporation trading as the Good Guys
19 Restaurant, 2133 Wisconsin Avenue, Northwest.
20 This is License No. ABRA-00899. This is a
21 Retailer CN License Renewal.

22 The protest issues are adverse

1 impact on peace, order and quiet.

2 My name is LaVerne Fletcher and I
3 am conducting the Roll Call Hearing as the
4 Board's Agent, pursuant to D.C. Official Code
5 1601.2.

6 We will now set a date for
7 mediation, a status hearing and a protest
8 hearing.

9 The date for the status hearing is
10 January 29, 2014 at 9:30 a.m., and the date
11 for the protest hearing is March 26, 2014 at
12 1:30 p.m.

13 MS. BLUMENTHAL: Ms. Fletcher?

14 AGENT FLETCHER: Yes.

15 MS. BLUMENTHAL: I am at memorial
16 service on March 26th and March 27th in
17 Philadelphia.

18 AGENT FLETCHER: On March 26th and
19 March 27th?

20 MS. BLUMENTHAL: Yes.

21 AGENT FLETCHER: Okay, what I'm
22 going to do, Ms. Blumenthal, I am going to go

1 ahead and leave you with that date and the ANC
2 can petition the ABC Board to set that at a
3 later date.

4 MS. BLUMENTHAL: Okay, thank you.

5 AGENT FLETCHER: Yes. Okay, we
6 need to set a date for mediation to occur
7 prior to January 29th. I'll give you the
8 first available dates in December.

9 Actually, we're in to January.
10 So, I'm going to give you the first available
11 dates in January.

12 The first available date in
13 January is Thursday, January 2nd. If that is
14 too soon around the holiday, I can move to the
15 next week, if that would be better.

16 MR. KLEIN: Yes, how about the 9th?

17 AGENT FLETCHER: The 9th is
18 available. Thursday, January 9th at 9:00,
19 10:00 or 11:00 a.m. Would that be good for
20 you, Ms. Blumenthal?

21 MS. BLUMENTHAL: Yes, if we could
22 do it at 10:00 or 11:00 a.m.

1 MR. KLEIN: Eleven would be great.

2 AGENT FLETCHER: Okay, so, we've
3 got mediation set for 11:00 a.m. on Thursday,
4 December 9th.

5 MS. BLUMENTHAL: January.

6 AGENT FLETCHER: January 9th,
7 Thursday, January 9th.

8 Okay, and Ms. Blumenthal, did you
9 write your contact information on that sheet?

10 MS. BLUMENTHAL: Yes, I did.

11 AGENT FLETCHER: Okay, thank you
12 very much. Any questions?

13 MS. BLUMENTHAL: No.

14 AGENT FLETCHER: Roll Call Hearing
15 is concluded. Thank you.

16 MR. KLEIN: Thank you.

17 MS. BLUMENTHAL: Thank you very
18 much.

19 AGENT FLETCHER: Thank you for
