CHAIRPERSON MILLER: All right.

I'm going to call the next case while we are waiting for that. That is Case No. 13-CMP-00228, Holiday Inn Central located at 1501 Rhode Island Avenue, N.W., License No. 16066, in ANC-2B.

MR. WICKRAMARATNE: Good morning.

CHAIRPERSON MILLER: Good morning.

MS. SCHMIDT: Good morning. Amy Schmidt, Assistant Attorney General on behalf of the District of Columbia.

MR. WICKRAMARATNE: Hi, I'm Marshall Wickramaratne on behalf of Holiday Inn Central. I'm the food and beverage director.

CHAIRPERSON MILLER: You're the what?

MR. WICKRAMARATNE: I'm the food and beverage director.

CHAIRPERSON MILLER: Okay. Do you

1 have some authorization to represent the --

2 MR. WICKRAMARATNE: Yes, ma'am.

3 CHAIRPERSON MILLER: -- licensee?

4 Yes? What's that?

5 MR. WICKRAMARATNE: Yes, actually

6 I got the hearing and I'm going to be

7 representing the hotel.

8 CHAIRPERSON MILLER: I mean, did

9 you file anything? Did the --

10 MR. WICKRAMARATNE: Yes.

11 CHAIRPERSON MILLER: -- owner --

12 MR. WICKRAMARATNE: I already

13 request a hearing.

14 CHAIRPERSON MILLER: Okay. So

15 could you spell your last name again?

16 MR. WICKRAMARATNE: W-I-C-K-R-A-M-

17 A-R-A-T-N-E. And if you don't mind, I just

18 wanted to let you know that you can call me

19 Marshall, since the last name is too long.

20 CHAIRPERSON MILLER: Okay. So but

21 my question is you're not the owner, you are--

22 MR. WICKRAMARATNE: No, I'm the

1 director there, food and beverage.

2 CHAIRPERSON MILLER: Okay. But do  
3 you -- okay. And my question is do you have  
4 any kind of written authorization from the  
5 owner?

6 MR. WICKRAMARATNE: No, I don't  
7 have it, no.

8 CHAIRPERSON MILLER: Okay. All  
9 right. So let me just ask you this then, do  
10 you know whether the owner received notice of  
11 this hearing?

12 MR. WICKRAMARATNE: I didn't --

13 CHAIRPERSON MILLER: How are you  
14 here?

15 MR. WICKRAMARATNE: I'm not sure  
16 about the owner, because we have a general  
17 manager.

18 CHAIRPERSON MILLER: Okay.

19 MR. WICKRAMARATNE: Definitely he  
20 already received that. And I'm the one who  
21 accept what you call the notice and I'm the  
22 one who came over here and requested a

1 hearing.

2 CHAIRPERSON MILLER: Okay. You  
3 accepted the notice and requested the hearing?

4 MR. WICKRAMARATNE: Yes, ma'am.

5 CHAIRPERSON MILLER: Did you  
6 consult with the owner?

7 MR. WICKRAMARATNE: Actually, I'm  
8 acting on behalf of the owner and the hotel.

9 CHAIRPERSON MILLER: Okay. I  
10 understand that you are saying that you are  
11 acting on behalf of them.

12 MR. WICKRAMARATNE: Okay.

13 CHAIRPERSON MILLER: I just want  
14 to know how do we know that the owner has  
15 authorized you to act on their behalf?

16 MR. WICKRAMARATNE: I'm sorry I  
17 didn't have that information with me.

18 CHAIRPERSON MILLER: Okay. All  
19 right. Okay. And I do have in my notes that  
20 notice was served on the establishment on  
21 October 25, 2013.

22 MR. WICKRAMARATNE: Yes, that's

1 correct, yes.

2 CHAIRPERSON MILLER: Okay. So,  
3 Ms. Schmidt, do you have anything to say?  
4 Otherwise, I think I'm just going to schedule  
5 this for --

6 MS. SCHMIDT: We have no offer.  
7 We have no offer in compromise.

8 CHAIRPERSON MILLER: Okay. So  
9 this is a status conference, Status Hearing.  
10 I'm going to schedule this for the hearing on  
11 February 12, 2014 at 10:00 a.m.

12 MR. WICKRAMARATNE: Okay.  
13 February 12th, yes.

14 CHAIRPERSON MILLER: Okay.

15 MR. WICKRAMARATNE: Yes.

16 CHAIRPERSON MILLER: If you are  
17 going to be representing the establishment at  
18 the hearing, you need to have a written  
19 authorization from the owner.

20 MR. WICKRAMARATNE: I just make  
21 sure that I do have that.

22 CHAIRPERSON MILLER: Okay.

1 MR. WICKRAMARATNE: When I come  
2 back on February 12th.

3 CHAIRPERSON MILLER: Okay. And in  
4 the meantime, you know, you are free to talk  
5 with the Office of Attorney General in the  
6 event that you work it out before the hearing.

7 MR. WICKRAMARATNE: Okay. We  
8 will.

9 CHAIRPERSON MILLER: Okay. All  
10 right. Then if you don't have any questions,  
11 that's all for this case. Thank you.

12 MR. WICKRAMARATNE: Thank you.
