3 MS. FLETCHER: Would the parties in  
4 the matter of Tortilla Coast please come  
5 forward. The parties in the matter of  
6 Tortilla Coast.

7 This is Case Number 13-PRO-00165,  
8 Clover Capitol Hill, LLC, trading as Tortilla  
9 Coast, 400 1st Street, S.E., License Number  
10 ABRA 085922. This is a Retailer CR,  
11 Substantial Change, Entertainment Endorsement  
12 Kareoke. The protest issues are adverse  
13 impact on peace, order, and quiet.

14 My name is LaVerne Fletcher, and  
15 I'm conducting the roll call hearing as the  
16 Board's agent pursuant to D.C. Official Code  
17 1601.2. Introductions beginning with the  
18 applicant.

19 MS. DICK: Rachel Dick, Clover  
20 Restaurant Group.

21 MS. FLETCHER: And what's the last  
22 name - first name again?

1 MS. DICK: Rachel.

2 MS. FLETCHER: And what's the last  
3 name, Rachel?

4 MS. DICK: Dick.

5 MS. FLETCHER: And could you spell  
6 that for the record please.

7 MS. DICK: D-I-C-K.

8 MS. FLETCHER: And Rachel.

9 MS. DICK: Yes.

10 MS. FLETCHER: And how do you spell  
11 that?

12 MS. DICK: R-A-C-H-E-L.

13 MS. FLETCHER: Thank you very much,  
14 and are you the applicant?

15 MS. DICK: I'm the comptroller for  
16 the company.

17 MS. FLETCHER: Okay. Thank you.  
18 Thank you very much, and now we have ANC 6B.

19 MS. ROLE: Good morning. My name  
20 is Susan Eads Role. I'm the Executive  
21 Director for ANC 6B.

22 COURT REPORTER: I'm sorry. Can

1           you - would you please push the button that  
2           says push to turn it on and repeat that  
3           please. Thank you.

4                       MS. ROLE: Thank you. Good  
5           morning. My name is Susan Eads Role. That's  
6           S-U-S-A-N E-A-D-S R-O-L-E, and I'm the  
7           Executive Director for ANC 6D.

8                       MS. FLETCHER: And ANC 6B does have  
9           standing as a protestant. We need to set a  
10          date for a mediation, a status hearing, and a  
11          protest hearing. I'll give you the dates for  
12          the status and protest hearings first.

13                      The status hearing is set for  
14          February 26, 2014, at 9:30.

15                      MS. DICK: I'm sorry, what time?

16                      MS. FLETCHER: 9:30, and the  
17          protest hearing is scheduled for April the 9th  
18          at 1:30 p.m., and, Ms. Dick, would you please  
19          put your contact information on that sheet if  
20          you haven't already. Thank you very much, so  
21          I'm going to tell you what dates are available  
22          for mediation prior to February 26.

1                   We have Wednesday, February 5, at  
2                   9:00, 10:00, 11:00 or 1:00. If that's not  
3                   good, I can keep moving. Is that a good date  
4                   for you, Ms. Dick?

5                   MS. DICK: Any of those times are  
6                   fine.

7                   MS. FLETCHER: Ms. Role?

8                   MS. ROLE: I believe that would  
9                   work. Would you please repeat the times.

10                  MS. FLETCHER: Yes, at nine  
11                  o'clock, ten o'clock, eleven or one. That's  
12                  a Wednesday.

13                  MS. ROLE: I think late morning  
14                  would probably work best.

15                  MS. FLETCHER: Do you want to do  
16                  11:30?

17                  MS. ROLE: Or 11.

18                  MS. FLETCHER: Eleven, okay, 11 is  
19                  good, so mediation is set for Wednesday,  
20                  February 5 at eleven. The mediation is held  
21                  here. You can just check in with the  
22                  receptionist, and I'll come out. My card is

1           on the table.  If you have any questions, you  
2           can give me a call.  Are there any questions  
3           at this stage?

4                           Okay, roll call hearing is  
5           concluded.  Thank you.

6                           Whereupon, at 10:07 a.m., the roll  
7           call hearing was adjourned.
