AMENDED AND RESTATED VOLUNTARY AGREEMENT

THIS AMENDED AND RESTATED VOLUNTARY AGREEMENT, dated this 30th day of March 2010 by and between NCS, Inc. t/a 18th & U Duplex Diner ("Applicant") and Vernon House Condominium ("Vernon House")

RECITALS

WHEREAS, Applicant and Vernon House entered into a Voluntary Agreement dated October 14, 1996;

WHEREAS, the parties desire to amend and restate the Voluntary Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

A. Sound and Vibration Control. Applicant acknowledges the requirements of DC Code Section 725 which prohibits any licensee from producing, by way of mechanical devices, machines, amplifiers or musical instruments, sound, noise, or music of such intensity that it may be heard in any premises other than the licensed premises. The roof-mounted mechanical systems and vents will be directed toward the 18th Street side of the premises. The operation of this equipment will not be significantly audible to nearby residents.

B. Venting. All kitchens vents shall be directed towards 18th Street and directed away from nearby residents.

C. Roof Drainage. The roof shall be maintained in such a way as to ensure that drainage at no time will threaten to flood any adjacent property. It is understood that the owner of the property has the ultimate responsibility in this regard.


D. Trash Removal and Health Safety.

- a. Applicant shall clear and maintain the trash area and keep it free of debris and weeds.
- b. Applicant shall maintain closed trash receptacles.
- c. Applicant shall hose down and disinfect the trash area to eliminate odors.
- d. Applicant shall dispose of trash in the receptacles in a quiet manner.
- e. Applicant shall bait the trash area for rats.

E. Availability of Voluntary Agreement. Licensee shall post a copy of this agreement in the premises and make it available for review by all employees.

F. Supersedes Previous Voluntary Agreement. This Amended and Restated Voluntary Agreement replaces the previous Voluntary Agreement between the parties dated October 14, 1996.




