**ORDER CANCELLING LICENSE**


The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Duck Sao Cho Tung An Cho, t/a 5th & N Street Market, located at 1245 S<sup>th</sup> Street, N.W., Washington, D.C., has failed to renew License No. ABRA-024374, a Retailer's Class B License and failed to pay the license fees for the period of 2008 to 2010. Specifically, you failed to renew your license by September 30, 2008, the deadline for all Retailer's Class B licenses, despite being notified of the renewal date and license fees for the period of 2008 to 2010.

On November 12, 2008, the Alcoholic Beverage Control Board (Board) issued an Order to Cease and Desist against Duck Sao Cho Jung An Cho, t/a 5th & N Street Market located at 1245 5<sup>th</sup> Street, NW, Washington, DC, pursuant to D.C. Official Code § 25-829 (2001), for failure to renew its Retailer's Class B License. *See Board Order Number 2008-282.*


