2 ROLL CALL HEARING

3 MS. LAVERNE FLETCHER: Would the parties
4 in the matter of 801 Restaurant & Bar please come
5 forward?

6 MALE SPEAKER: How you doing?

7 MS. LAVERNE FLETCHER: Hi, good morning.

8 MALE SPEAKER: Good morning.

9 MS. LAVERNE FLETCHER: This is Case #16-
10 PRO-00112, 801 Restaurant, LLC, trading as 801
11 Restaurant & Bar, 801 Florida Avenue, NW, License
12 #ABRA-103120. This is a Retailer Class CT license
13 renewal. Protest issues are adverse impact on
14 peace, order, and quiet.

15 My name is Laverne Fletcher, conducting
16 the roll call hearing as the Board's agent. Uh,
17 introductions beginning with the applicant,

19 MR. MICHAEL TOBIN: I am Michael Tobin,
20 representing 801 Restaurant & Bar.
