2 CHAIRPERSON ANDERSON: I'm going to speed
3 up the calendar a little bit. I'm going to move
4 into our afternoon calendar. We're supposed to
5 have a fact finding hearing on Artechouse,
6 license #103519. This case has been continued to
7 September 14th at 11:00 a.m.

8 CHAIRPERSON ANDERSON: The next matter is
9 a protest hearing for case #16-PRO-00036. Ben's
10 Upstairs Ten01, license #93103. This case has
11 been continued until September 21st at 1:30 p.m.

12 CHAIRPERSON ANDERSON: The next matter
13 is a protest hearing, case #16-PRO-00035,
14 Drafting Table, license #89190. This case has
15 been continued to September 21st at 4:30 p.m.

16 The next matter on our calendar is
17 protest hearing Case #16-PRO-00025, Whiskey
18 Village, license #102077. This case has been
19 canceled due to submission of a settlement
20 agreement for the board's approval.

21 CHAIRPERSON ANDERSON: The first matter
22 on our licensing agenda is to review application

1 for class change from CR to C Tavern, Stonefish
2 Grill and Lounge, license #094562. I make a
3 motion that this matter be placarded. Is there a
4 second?

5 MR. SHORT: Second.

6 CHAIRPERSON ANDERSON: Mr. Short has
7 seconded the motion. All those in favor say aye.
8 (chorus of ayes.) Those opposed? (No audible
9 response.) The matter passed 4-zero-zero.

10 The next matter is review a request for
11 change of hours for Mignot, license #100407. I
12 make a motion that this matter be placarded. Is
13 there a second?

14 MR. SHORT: Second.

15 CHAIRPERSON ANDERSON: Mr. Short has
16 seconded the motion. All those in favor say aye.

7 change hours for La Piquette, license #093706. I
8 make a motion that this matter be approved. Is
9 there a second?

10 MS. MILLER: Second.

11 CHAIRPERSON ANDERSON: Ms. Miller
12 seconded the motion. Those in favor say aye.
13 (Chorus of ayes.) Those opposed? (no audible
14 response.) The matter passed 5-zero-zero

15 The next matter is review a request for
16 change hours for St. Gregory Luxury Hotel and
17 Suites, license #098868. I make a motion that
18 this matter be approved. Is there a second?

19 MR. SILVERSTEIN: Second.

7 CHAIRPERSON ANDERSON: Ms. Miller
8 seconded the motion. Those in favor say aye.
9 (Chorus of ayes.) Those opposed? (no audible
10 response.) The matter passed 5-zero-zero

11 The next matter is review a request for
12 change hours for Embassy Suites Downtown, license
13 #07890. Is there a second?

14 MR. SILVERSTEIN: Second.

15 CHAIRPERSON ANDERSON: Mr. Silverstein
16 has seconded the motion. Those in favor say aye.
17 (chorus of ayes.) Those opposed? (no audible
18 response.) The matter passed 5-zero-zero.

19 The next matter is a review application
20 for sidewalk café with seating for 50 patrons,
21 1831, license #099805. I make a motion that this
22 matter be approved. Is there a second?

1 MR. ALBERTI: Second.

2 CHAIRPERSON ANDERSON: Mr. Alberti
3 seconded the motion. Those in favor say aye.
4 (chorus of ayes.) Those opposed? (no audible
5 response.) The matter passed 5-zero-zero.

6 We now move to our secondary
7 supplementary licensing agenda. The first matter
8 on our secondary supplementary licensing agenda
9 is review a request for a stipulated license to
10 operate a class D restaurant, Wagshal's, license
11 #101706. I make a motion this matter be
12 approved.

13 MS. MILLER: Second.

14 CHAIRPERSON ANDERSON: Ms. Miller
15 seconded the motion. Those in favor say aye.
16 (Chorus of ayes.) Those opposed? (no audible
17 response.) The matter passed 5-zero-zero

18 We now move to our cancellation agenda.
19 On our cancellation agenda, the matters that are
20 up for cancellation are: Westchester Dining
21 Room, license #095631, Johnny's Half Shell,
22 license #074573, Cities DC, license #077812, and

1 S&J Liquor, license #009122. I make a motion
2 that the licenses for all these establishments
3 listed on our cancellation agenda as mentioned
4 earlier, be approved. Is there a second?

5 MR. SILVERSTEIN: Second.

6 CHAIRPERSON ANDERSON: Mr. Silverstein
7 has seconded the motion. Those in favor say aye.
8 (chorus of ayes.) Those opposed? (no audible
9 response.) The matter passed 5-zero-zero. ()

10 CHAIRPERSON ANDERSON: I just need to go
11 back on the record regarding the cancellation
12 agenda. As far as the cancellation agenda that
13 was previously disclosed, I would like to make a
14 change. The change is regarding Cities DC, ABRA
15 license #077812. A motion was made earlier in
16 the afternoon to cancel this license, and I make
17 a motion that we withdraw the cancellation of
18 this license. Is there a second?

19 MR. ALBERTI: Second.

20 CHAIRPERSON ANDERSON: Mr. Alberti
21 seconded the motion. Those in favor say aye.
22 (chorus of ayes.) Those opposed? (no audible

1 response.) The matter passed 5-zero-zero so I
2 just want the record to reflect that the board
3 has today reinstated the license for Cities DC,
4 ABRA #077812. All right, thank you.

5 We now move to our legal agenda. The
6 first matter on our legal agenda is the review of
7 Russia House's Restaurant and Lounge motion for
8 reconsideration A&A Restaurant Group, Russia
9 House Restaurant and Lounge, license #080952, I
10 make a motion that this matter be approved. Is
11 there a second?

12 MS. MILLER: Second.

13 CHAIRPERSON ANDERSON: Ms. Miller
14 seconded the motion. Those in favor say aye.
15 (Chorus of ayes.) Those opposed?

16 MR. ALBERTI: Opposed.

17 CHAIRPERSON ANDERSON: The matter passed
18 4 to one with Mr. Alberti in opposition.

19 The next matter is review of
20 Councilmember Kenyan McDuffie's Letter of Support
21 of the Liquor License Moratorium Amendment
22 Petition for the Langdon Park Community in Ward 4

1 -- Ward 5 -- this matter is an FYI.

2 The matter is review of a settlement
3 agreement between Showtime and the Group of Five
4 or More, for Showtime, license #089186. I make a
5 motion that this matter be postponed. Is there a
6 second?

7 MR. SILVERSTEIN: Second.

8 CHAIRPERSON ANDERSON: Mr. Silverstein
9 has seconded the motion. Those in favor say aye.
10 (chorus of ayes.) Those opposed? (no audible
11 response.) The matter passed 5-zero-zero.

12 We now move to our supplementary legal
13 agenda. The first matter on our supplementary
14 legal agenda is review of a letter from Chief
15 Cathy Lanier regarding an incident at Player's
16 Lounge, license #001271. I make a motion that
17 this matter be postponed until submission of the
18 case in court. Is there a second?

5 license #098205. I make a motion that this
6 matter -- sorry, this is just an FYI for the
7 board. Thank you. All right, so we're off the
8 record again.

9 CHAIRPERSON ANDERSON: Let's go on the
10 record for a minute please, okay? We're back on
11 the record. I'm going to call case #16-PRO-
12 00038, the Showtime. This matter has been
13 cancelled due to submission of a settlement
14 agreement.

15 (Whereupon the above-entitled matter was
16 concluded.)
