1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: Now, the second case
3 is now Case Number 15-CMP-00749. Are there any
4 preliminary matters on this particular case?

5 MR. RIVERO: Fernando Rivero for the
6 District of Columbia. On this case and the parties have
7 an Offer in Compromise to present to The Board at this
8 time consisting of a fine of \$300 payable in 30 days.
9 And if the payment is not received in that time, the
10 license will be suspended until payment is received.

11 CHAIRPERSON ANDERSON: Ms. Garcia, again, in
12 the second case -- Case Number 15-CMP-00749 it's my
13 understanding that there is an Offer in Compromise of
14 \$300 that will be payable in 30 days. If it's not
15 payable in 30 days, the license will be suspended until
16 it's paid. Is this your understanding of the Offer in
17 Compromise?

18 MS. GARCIA: Yes.

19 CHAIRPERSON ANDERSON: And are you also
20 aware that by accepting an Offer in Compromise you are
21 giving up your right to a hearing?

22 MS. GARCIA: Yes.

1 CHAIRPERSON ANDERSON: And you're also aware
2 that by -- that you're also giving up your right to
3 appeal this matter?

4 MS. GARCIA: Correct. Yes.

5 CHAIRPERSON ANDERSON: All right. Thank
6 you. I then make a motion that this Offer in Compromise
7 of -- I -- I then make a motion that this Offer in
8 Compromise of \$300 payable in 30 days. If it's not
9 payable in 30 days, the license will be suspended. I
10 make -- I make a motion that this be accepted.

11 MR. SHORT: Second.

12 CHAIRPERSON ANDERSON: Mr. Short has
13 seconded the motion. Any -- any discussion? Those in
14 favor say aye. [Chorus of ayes]. Those opposed. [No
15 audible response]. The matter passed 4-zero-zero.
16 Thank you. And we will -- we'll give you two documents
17 to sign in a couple minute. All right. Thank you.

18 MS. GARCIA: Thank you.

19 CHAIRPERSON ANDERSON: Thank you.

20 (Whereupon the above-entitled matter was
21 concluded.)
