2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Would the parties
4 in the matter of Hank's Oyster Bar please come
5 forward? The parties in the matter of Hank's
6 Oyster Bar? If the parties in the matter of
7 Hank's Oyster Bar would please come forward?
8 This is case #16-PRO-00045. Hank's on the Hill,
9 LLC, trading as Hank's Oyster Bar. My name is
10 Laverne Fletcher. I'm conducting the Roll Call
11 Hearing as the Board's agent pursuant to D.C.
12 Official Code 1601.2. Introductions beginning
13 with the applicant please.

14 MR. KLINE: Good morning, Andrew Kline on
15 behalf of the applicant.

16 CHAIRPERSON FLETCHER: Thank you, Mr. Kline.
17 And present on behalf of ANC 6B?

18 MS. HOSKINS: Good morning, Diane Hoskins.

19 CHAIRPERSON FLETCHER: Diane would you spell
20 your name for the record, please?

21 MS. HOSKINS: Sure. D-I-A-N-E, H-O-S-K-I-NS

22 CHAIRPERSON FLETCHER: H-O-F-K-I--

1 MS. HOSKINS: H-O-S as in Sam --

2 CHAIRPERSON FLETCHER: Mm hmm.

3 MS. HOSKINS: K-I-N as in Nancy, S as in Sam.

4 CHAIRPERSON FLETCHER: Okay, thank you. Is

5 Mr. Tomasso present?

6 MR. ROZEBOOM: I'm Mr. Rozeboom and I'm here

7 for him.

8 CHAIRPERSON FLETCHER: Okay, you're here for,

9 could you state who you're here for?

10 MR. ROZEBOOM: I'm sorry?

11 CHAIRPERSON FLETCHER: Who are you here for?

12 MR. ROZEBOOM: Ronald Tomasso.

13 CHAIRPERSON FLETCHER: Thank you. And would

14 you spell his last name?

15 MR. ROZEBOOM: T-O-M-A-S-S-O.

16 CHAIRPERSON FLETCHER: Mr. Tomasso claimed to

17 be an abutting property owner. Do you have a

18 letter designating as his representative?

19 MR. ROZEBOOM: I do.

20 CHAIRPERSON FLETCHER: Okay, good. Thank

21 you.

22 MR. ROZEBOOM: Also, we are the abutting

1 property.

2 CHAIRPERSON FLETCHER: Okay, thank you.

3 MR. ROZEBOOM: Thank you.

4 CHAIRPERSON FLETCHER: Mr. Rozeboom, would
5 you state your name and spell it for the record,
6 please?

7 MR. ROZEBOOM: Sure. Name is spelled R-O-Z-
8 E-B-O-O-M, first name Gary.

9 CHAIRPERSON FLETCHER: The properties do abut
10 according to the geographic information system.
11 Mr. Tomasso does have standing as an abutting
12 property owner, ANC 6B has standing as a
13 protestant. We need to set a date for
14 mediation, a status hearing and a protest
15 hearing.

16 I'll give you the date for the status and
17 protest hearing first. The date for the status
18 hearing is September 7 at 9:30 a.m., that's
19 September 7th. The date for the protest hearing
20 is October 19 at 1:30. We need to set a date for
21 mediation. We're into the month of July. The
22 next available date for mediation is Tuesday,

1 July the 19th at 9:00, 10:00 or 11:00.

2 MR. KLINE: That works for the applicant,
3 11:00.

4 CHAIRPERSON FLETCHER: Is that okay for the
5 ANC and Mr. Tomasso?

6 MS. HOSKINS: We prefer 9:00 if possible.

7 CHAIRPERSON FLETCHER: What about somewhere
8 in between?

9 MS. HOSKINS: Oh, you said 9:00, 10:00 or
10 11:00.

11 CHAIRPERSON FLETCHER: 9:00, 10:00 or 11:00.

12 MS. HOSKINS: 10:00 would be --

13 CHAIRPERSON FLETCHER: Would 10:00 work for
14 you Mr. Kline.

15 MR. KLINE: That's great, yeah that's fine if
16 that works for -- what was the date in July?

17 MS. HOSKINS: July 19th.

18 CHAIRPERSON FLETCHER: July 19th.

19 MS. HOSKINS: At 10:00 a.m.

20 CHAIRPERSON FLETCHER: At 10:00 a.m. Yes.
