**ORDER DENYING APPLICANT'S REQUEST FOR REINSTATEMENT**

The Application filed by Capitol Hospitality, LLC, t/a Capitol Skyline Hotel, for renewal of its Retailer's Class CH License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on June 3, 2013, in accordance with D.C. Official Code § 25-601 (2001).

On June 3, 2013, the Board dismissed the Application, because the Applicant failed to appear at the Roll Call Hearing. *See* Board Order No. 2013-264.

On June 13, 2013, Jeff Ragonese, on behalf of the Applicant, submitted a Request for Reinstatement indicating that he was unable to attend the Roll Call Hearing due to a family emergency. Mr. Ragonese further claims that due to the short notice of the family emergency, he forgot to send another representative to appear on behalf of the Applicant.

Based upon the above, the Board finds that Mr. Ragonese made no effort to notify the Board or its administrative personnel of his inability to attend the Roll Call Hearing. Nor did Mr. Ragonese send a representative to attend the Roll Call Hearing in his stead. Therefore, the Board finds no good cause to reinstate the Applicant's Application, pursuant to 23 DCMR §1602.

**ORDER**






