2 SHOW CAUSE HEARING (STATUS)

3 CHAIRPERSON ANDERSON: The next case on
4 our show cause hearing (status) calendar is case
5 #16-CC-00079, Dirty Martini Inn Bar, license
6 #83919. Will the parties please approach and
7 identify themselves for the record, please?

8 MR. RIVERO: Good morning, board members.
9 Fernando Rivero for the District of Columbia.

10 CHAIRPERSON ANDERSON: Good morning, Mr.
11 Rivero.

12 MR. RAHMEN: Michael Rahmen.

13 CHAIRPERSON ANDERSON: Your name, sir?

5 case. The licensee has pointed out there's some
6 evidence that he'd like reviewed, so I'm going to
7 take an opportunity to do that.

8 CHAIRPERSON ANDERSON: All right. Then this
9 matter is scheduled for a show cause hearing on -
10 - do you want a show cause hearing on status or
11 just move to a regular show cause hearing.

12 MR. RIVERO: We should keep the show cause
13 hearing as it is and if there's a need for an
14 additional status hearing, I will contact the
15 board.

16 CHAIRPERSON ANDERSON: Then this matter is
17 scheduled for a show cause hearing on December 7
18 at 3:30 p.m.
