**ORDER VACATING CEASE AND DESIST**


On May 1, 2014, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2014-152 ordering Maharjan and Lama, Inc., t/a Dalchinni/Le Mirch (Respondent), holder of a Retailer's Class CR License No. ABRA-060762, to stop selling, serving, or permitting the consumption of alcoholic beverages at its establishment until payment of the second year license fees and any associated fines are received by ABRA.

On May 2, 2014, the Respondent paid the license fees for the period of 2014 to 2015 and the associated late fees.






