ORDER TO CEASE AND DESIST


The Alcoholic Beverage Control Board (Board) has been notified by the Department of Consumer and Regulatory Affairs (DCRA) that Fasil Ethiopian Restaurant, LLC, t/a Fasil Ethiopian Restaurant's (Licensee), at premises 1608 7th Street, N.W., Washington, D.C., corporation was revoked on November 14, 2011, for not filing its 2011 biannual report. In accordance with the laws and regulations of the District of Columbia, the Licensee shall not engage in the sale or service of alcoholic beverages unless its corporation is in good standing.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 22nd day of February, 2012, to **STOP selling, serving, or permitting the consumption of alcoholic beverages at 1608 7th Street, N.W., Washington, D.C.** You may not allow the sale of alcoholic beverages on the premises until your ABC License is reinstated by the Board.






