**ORDER VACATING CANCELLATION OF LICENSE AND
REINSTATING LICENSE**


On May 4, 2016, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2016-249 cancelling American Foreign Service, t/a Foreign Service Club (Licensee), License No. ABRA-001008. Specifically, the Licensee failed to renew his license by March 31, 2016, the deadline for all Retailer's Class CX Club licenses. *See* Board Order No. 2016-249.

On November 3, 2016, the Licensee renewed its license and paid the license fees for the period of 2016 to 2019 and the associated late fees.




ORDER CANCELLING LICENSE

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that American Foreign Service, t/a Foreign Service Club (Respondent), has failed to renew its License No. ABRA-001008, a Retailer's Class CX Club license. Specifically, the Respondent failed to renew its license by March 31, 2016, the deadline for all Retailer's Class CX Club licenses, despite being notified of the renewal date.

On April 27, 2016, the Alcoholic Beverage Control Board (Board) issued an Order to Cease and Desist against American Foreign Service, t/a Foreign Service Club, pursuant to D.C. Official Code § 25-829 (2001), for failure to renew its Retailer's Class CX Club License.

It is hereby **ORDERED** on this 4th day of May, 2016, that American Foreign Service's License No. ABRA-001008 is **CANCELLED**. A copy of this Order shall be sent to the Respondent.




