1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: The next case on
3 our calendar is Case No. 15-CMP-00544,
4 Fuddruckers, License No. 86154. Would the
5 parties please approach.

6 MR. RIVERO: Good morning, board members.
7 Fernando Rivero with the District of Columbia
8 standing in for Amy Schmidt.

9 MR. CORCELIUS: Good morning. My name is
10 Lynn Corcelius. I'm the general manager of
11 Fuddruckers, 7th Street.

12 CHAIRMAN ANDERSON: And do you have a
13 representation that you're authorized to
14 (inaudible) the agency?

15 MR. CORCELIUS: Yes, I am.

16 CHAIRMAN ANDERSON: And how so?

17 MR. CORCELIUS: I've been contacted by my
18 legal department in Houston to give me
19 authorization to --

20 CHAIRMAN ANDERSON: So do you have it?

21 MR. CORCELIUS: I have an email -- an
22 email that stated such.

1 CHAIRMAN ANDERSON: All right. Can you
2 pass that up for us?

3 Your name again, sir?

4 MR. CORCELIUS: It's Lynn, L-y-n-n.

5 (Pause)

6 CHAIRMAN ANDERSON: The email, it's
7 sufficient.

8 Are there preliminary matters?

9 MR. RIVERO: Yes. The parties have an
10 offer in compromise to present to the board at
11 this time, and the offer consists of a fine of
12 \$500, payable within 30 days. If payment is not
13 received 30 days, the license will be suspended
14 until payment is received.

15 CHAIRMAN ANDERSON: Mr. Lynn, the
16 government has stated that there is an offer in
17 compromise of a fine of \$500 payable in 30 days.
18 Is this your understanding of the offer in
19 compromise?

20 MR. CORCELIUS: It is.

21 CHAIRMAN ANDERSON: And that if the fine
22 is not paid, your license will be suspended?

1 MR. CORCELIUS: Correct.

2 CHAIRMAN ANDERSON: Are you aware that by
3 accepting this on behalf of Fuddruckers, that by
4 accepting this offer in compromise you're waiving
5 your right to a hearing?

6 MR. CORCELIUS: I do.

7 CHAIRMAN ANDERSON: And you're also aware
8 that you're waiving your right to appeal this
9 matter?

10 MR. CORCELIUS: Yes.

11 CHAIRMAN ANDERSON: Okay. Are there any
12 questions from any board members?

13 Hearing none, I make a motion that this
14 offer in compromise of \$500 fine, payable in 30
15 days, and if it's not paid in 30 days, the
16 license will be suspended. I make a motion that
17 the offer be accepted. Is there a second?

18 MR. SILVERSTEIN: Second.

19 CHAIRMAN ANDERSON: Mr. Silverstein
20 seconds the motion. Those in favor say aye.

21 [Chorus of Ayes.]

22 Those opposed?

1 MR. ALBERTI: Oppose.

2 CHAIRMAN ANDERSON: The matter passes 4-1
3 with Mr. Alberti opposing the motion.

4 And Ms. Walker will provide you with a
5 resolution form. All right. Thanks.

6 MR. CORCELIUS: Thank you.

7 [Whereupon, the above-entitled
8 matter was concluded.]
