**ORDER ON DISMISSAL OF APPLICATION AND
PROTESTS OF ECKINGTON CIVIC ASSOCIATION,
HANOVER AREA CIVIC ASSOCIATION, AND ANC 5C**

The Application filed by Full Yum Carryout Corporation, t/a Full Yum Carryout, for a new Retailer's Class A License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on October 24, 2011, in accordance with D.C. Official Code § 25-601 (2001).

On October 24, 2011, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed the Application and the

Protests of ANC 5C and Eckington Civic Association for failure to appear at the Roll Call Hearing. The Board also dismissed the Protest of Hanover Area Civic Association, because its incorporation status is revoked according to the Department of Consumer and Regulatory Affairs's (DCRA) website. The Applicant, ANC 5C, Eckington Civic Association, and Hanover Area Civic Association may file a Request for Reinstatement within ten (10) days from the date of this Order.

The Board takes administrative notice that Eckington Civic Association incorporation status is revoked according to DCRA's website. In addition, the Board granted "conditional standing" to Bates Area Civic Association, which must submit a letter designating Margaret Stevens as its representative by October 26, 2011.

ORDER

The Board does hereby, this 26th day of October, 2011, **DISMISS** the Application filed by Full Yum Carryout Corporation, t/a Full Yum Carryout, for a new Retailer's Class A License; and the Protests of ANC 5C, Eckington Civic Association, and Hanover Area Civic Association.


