**ORDER GRANTING ANC 6D'S REQUEST FOR REINSTATEMENT**

The Application filed by Hill Country DC, LLC, t/a Hill Country Home Stand, for a new Retailer's Class CT License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on September 3, 2013 and a Protest Status Hearing on October 2, 2013, in accordance with D.C. Official Code § 25-601 (2001).

On October 2, 2013, the Board dismissed the Protest of ANC 6D because ANC 6D failed to appear at the Protest Status Hearing. *See* Board Order No. 2013-437.

On October 15, 2013, ANC 6D filed a request for reinstatement indicating that the ANC 6D's representative, Commissioner Ron McBee, was unable to attend the Protest Status Hearing due to illness.

The Licensee did not object to the ANC 6D's request for reinstatement.



**ORDER**


