<p style="text-align: right;">6</p> <p>1 MR. SOURI: -- exactly but it's been going on 2 for decades. 3 CHAIRPERSON MILLER: Wow, okay. So -- and 4 have you ever had come here before the Board? 5 MS. SOURI: No. 6 MR. SOURI: No, this is the first time. 7 CHAIRPERSON MILLER: Okay. 8 MR. SOURI: I've been getting Class F permits 9 for the five -- last five or six years. So this is my 10 first occasion. 11 CHAIRPERSON MILLER: Okay. 12 MR. SOURI: This is completely new to us. 13 CHAIRPERSON MILLER: Okay, okay. Well, it's 14 nothing that you should be overly concerned about. 15 It's just that the Board is looking through lots of 16 applications and it spots some that are -- have large 17 crowds and just want to come -- you to come in and 18 address any of the concerns that are often raised when 19 that occurs. So -- 20 MR. SOURI: Sure. I would like to point out 21 that the primary reason for the bazaar is ethnic; 22 crafts, food, music, dance. SOURI: We do. 4 CHAIRPERSON MILLER: What kind of 5 entertainment do you -- 6 MR. SOURI: It's music -- DJ. But it's 7 almost exclusively Arabic music. 8 CHAIRPERSON MILLER: Okay. Have you 9 coordinated your event with MPD or the fire department 10 or DCRA or EMS, any of those agencies? 11 MR. SOURI: I talked to our council chair 12 about that. And according to what she says, yes, we 13 do. I don't do that personally but it appears that 14 some member of our church council does. But honest, I 15 don't know who. And apparently, that's also done just 16 prior to the event, not any time sooner. In other 17 words, they just notify the local precinct. 18 CHAIRPERSON MILLER: They notify them that -- 19 about the event happening but they don't -- for 20 instance, you don't -- you're not coordinating any 21 patrols from MPD or anything like that? 22 MS. SOURI: But they come -- they come at</p>

SOURI: Yes. 16 CHAIRPERSON MILLER: Okay. Why is that? 17 MR. SOURI: Because everything is still 18 outside in the parking lot. 19 CHAIRPERSON MILLER: Okay. 20 MR. SOURI: I mean, most everything is secure 21 inside the building but there are still chairs, tables, 22 tents, that sort of thing -- speakers.</p>	<p style="text-align: right;">9</p> <p>1 appointed times. They patrol the area. 2 CHAIRPERSON MILLER: Okay. So who is 3 handling the alcohol and how is it being handled? 4 MR. SOURI: There is one individual who 5 handles the sales. His photograph is in one of those 6 pictures. His name is Javal Moutlan (ph). And he 7 handles the bulk sales. 8 CHAIRPERSON MILLER: So does he check IDs? 9 MR. SOURI: I really don't know that. 10 MS. SOURI: Yeah, he does. 11 MR. SOURI: He does? I mean, I've never 12 really seen him do that. 13 CHAIRPERSON MILLER: Is -- who is he? Is he 14 -- is he -- what's his profession? 15 MR. SOURI: He's a -- 16 MS. SOURI: On the Board. 17 MR. SOURI: He's just on our council. 18 CHAIRPERSON MILLER: He's on your council. 19 Is he trained at all in checking IDs or anything like 20 that? 21 MS. SOURI: We know -- we know everybody who 6 comes to the church. 7 CHAIRPERSON MILLER: You know everybody who 8 comes? 9 MS. SOURI: Yeah. 10 MR. SOURI: Well, pretty much the 11 parishioners but it's open to the community. You know, 12 we want families to come. So I strongly doubt that we 13 would be selling to minors. It's a church. SOURI: It's almost as if it were a 2 second thought. 3 CHAIRPERSON MILLER: Okay. Are you selling 4 other soft drinks? 5 MS. SOURI: Yes. 6 CHAIRPERSON MILLER: Okay. 7 MS. SOURI: Basically just to patrol the 10 area, just to make sure that there's -- there are no 11 problems. It isn't just to govern the alcohol sales. 12 MR. ALBERTI: No, right. I understand. And 13 then you said, "Volunteers." What do they -- what's 14 their duties? 15 MR. SOURI: Well, they are members of the 16 congregation. 17 MS. SOURI: We have a -- we have a staff in 18 the kitchen. There's staff outside selling stuff. 19 MR. ALBERTI: Okay. So their duties are -- 20 their duties are to -- they have other responsibilities -- 21 MS. SOURI: Yeah. 22 MR. Are they selling other things besides beer and 20 wine? 21 MR. SOURI: No. 22 MS. SOURI: No. But in the food --</p>

JONES: -- had in the past? 21 MR. SOURI: Right. 22 MR. JONES: Over the entire span of --</p>	24	<p>1 new roof. So it would -- we wouldn't die but it would 2 -- it would certainly cut into our profits for that 3 particular bazaar. It's a one-year affair -- 4 MR. JONES: Right. 5 MR. SOURI: -- that we can make money off of 6 the community. So we try to maximize that affair to 7 get as much as we can. So to give a percentage, 15 8 percent, 12 percent. 9 MR. JONES: Fifteen -- twelve to fifteen 10 percent? Okay. Thank you. Thank you, Madam Chair. 11 CHAIRPERSON MILLER: Okay. Others? I have a 12 question about the selling of the beer and wine. Did 13 you say you only do it by the bottle? 14 MR. SOURI: Yes. 15 MS. SOURI: Yes. 16 CHAIRPERSON MILLER: Do you -- is it both to 17 drink there and/or to take home or what? 18 MS. SOURI: Yes, yes. 19 MR. SOURI: I would say primarily to take 20 home. It's really not -- it's -- the idea is the sales. 21 So it's really not to be consumed there on the 22 premises, but rather for people to take home and</p>
23	<p>1 MR. SOURI: Right, exactly. 2 MR. JONES: -- whether it's three days, two 3 days (inaudible)? 4 MR. SOURI: From no less than 1000, no more 5 than 1500. 6 MR. JONES: Okay. So at the high end, 1500 -- 7 MS. SOURI: Yeah. 8 MR. JONES: -- maximum spanning the three 9 days -- 10 MS. SOURI: Yes. 11 MR. JONES: -- so if you divide that easily -- 12 MR. SOURI: And I think that's reason -- 13 MR. JONES: -- it'd be about 500 per day. 14 MR. SOURI: Depending on the weather. 15 MR. JONES: Depending on the weather. 16 MS. SOURI: Yeah. 17 MR. JONES: Okay. Fair enough. And you also 18 noted that the sale of alcohol was not a primary focus 19 obviously. What will be the impact of not being able 20 to sell alcohol at your bazaar? 21 MR. SOURI: Well, I mean, we would lose some 22 money. The church needs money. Actually now we need a</p>	25	<p>1 consume at home. So I would imagine people reasonably 2 would open a bottle and have some wine during and, you 3 know, outside in the tent. 4 There are no good places inside to sit in the 5 -- we have mostly just the food service. Then they 6 take their food outside and they sit at the tables in 7 the tent. But I would imagine some of them, yes, they 8 will buy a bottle and open it up and drink the wine 9 there -- or beer. 10 CHAIRPERSON MILLER: Or beer? And the beer 11 you sell by the case? 12 MR. SOURI: Yes. 13 CHAIRPERSON MILLER: Okay. Do -- I'm looking 14 at the photo that you put here. So does this gentleman 15 -- does he actually serve any wine or he just sells the 16 bottles? 17 MR. SOURI: He just stays there in his little -- 18 MS. SOURI: He'll -- 19 MR. SOURI: -- corner. And he -- 20 MS. SOURI: He'll have tasting cups for 21 people to see what -- if that's what they want. 22 CHAIRPERSON MILLER: Right. Okay.</p>

But I'm unsure if there's ever been one-day off- 4 premise license being authorized for the off-site sale 5 of alcohol. 6 CHAIRPERSON MILLER: Okay. Okay, wait. 7 Would you repeat that so that Ms. Davis can hear what 8 you're concerned about? 9 MR. PARKER: I'm unaware -- and I may be 10 missing something -- of an off-premise one-day license 11 being issued by the Board to say that a licensee can 12 operate under a temporary Class F or G license and 13 provide all sales service, that being closed containers 14 of alcohol being sold and patrons being allowed to take 15 that alcoholic beverage off-premise to the -- to their 16 home. 17 CHAIRPERSON MILLER: I see. 18 MR. PARKER: I just -- I'm unaware of a</p>	<p style="text-align: right;">29</p> <p>1 legal issue and that is that normally, when we look at 2 events like yours, we're talking about people selling 3 alcohol to be drink -- to drink there, you know, I 4 mean, cups, you know, but the beer or wine. And in 5 your situation, you're selling bottles and cases to be 6 taken home off premises. 7 So we just want to look at that legal issue - 8 - I just discussed it with our attorney and just 9 double-check the law -- and get back to you shortly, 10 probably within a day or so.
