It's Case Number 11- 5 CMP-00308, Carolina Palace, or Carolina, 3700 14th 6 Street Northwest, License Number 76011, in ANC 4-C. 7 MR. The message indicated that the licensee's</p>	<p style="text-align: right;">4</p> <p>1 It turns out not really to be a subpoena. 2 It's in fact a court order from Judge Laura Cordero. 3 His voicemail message to me on Monday called her Laura 4 Rosario, but there is no Judge Laura Rosario. Her name 5 is Laura Cordero, and the actual subpoena turns out to 6 be a court order to testify this week, and he's not a 7 witness. He's actually the defendant. So, he's being 8 sued, and he is testifying in court, and, therefore, 9 unable to appear today. 10 That document does, in fact, exist. I have 11 confirmed it and have forwarded it to your general 12 council early this morning. Naturally, she has not 13 seen it. But in anticipation of this document very 14 late yesterday, which it could not be helped, I filed 15 that motion, which is an obvious consent motion for 16 continuance. He called me during the lunch break, and I 10 indicated to him that I needed to see a subpoena, 11 because I wanted to understand with certainty that this 12 was the case.
