Next and last on 4 our hearing schedule is a protest hearing, Case No. 12- 5 PRO- 00036, Alabama Express, located at 2846 Alabama 6 Avenue, S.E., License No. 24971. Yeah, go ahead. And so we're going to take a five-minute 2 break. 3 (WHEREUPON, at 3:44 p.m., the hearing went 4 off record until 4:14 p.m.) 5 CHAIRPERSON MILLER: Okay. We are ready to 6 go. I can't remember. Did you introduce yourselves for 7 the record? Okay. So it's now 4:14 in the afternoon. 8 And this case was delayed from 1:00 to 2:30. And our 9 staff did contact the ANC 7B, who was a protestant in 10 this case. Our staff spoke with a Mr. Jordan and Ms. 11 Williams to tell them that this was going to be on the 12 schedule for 2:30. And at 4:15 they haven't showed up. 13 And our staff called again and left messages. 14 So at this point they have notice for sure that the 15 hearing was going to be taking place this afternoon. 16 And no one has appeared to prosecute the case. And 17 they are the only party in this case. 18 Therefore, I am going to move to dismiss the 19 protest for two reasons, (1) failure to prosecute here 20 today to make their case, and second, they did not file 21 their PIF form as well. And the parties have been 22 instructed -- I instruct the parties -- I think Ms.</p>
<p style="text-align: right;">3</p> <p>1 owners? 2 MR. IN SUH BAIK: Yeah, I'm the owner. 3 CHAIRPERSON MILLER: Both of you? 4 MR. IN SUH BAIK: No. 5 CHAIRPERSON MILLER: No. You're the owner? 6 MR. So the combination of those two reasons, I 4 would move that we dismiss the protest. Do I have a 5 second? 6 MR. NOPHLIN: Second. 7 CHAIRPERSON MILLER: Do -- would others like 8 to make comments on the -- Okay. 9 MR. SILVERSTEIN: Very, very briefly. 10 CHAIRPERSON MILLER: Okay. 11 MR.
