6 Beverage Control Board.

5 like you to take a seat at the table and sign in. This  
6 is to ensure that the record will reflect the accurate  
7 spelling of your name. The open meeting set up  
8 requires that the public hearing on each case be open  
9 to the public.

10           The Board may, consistent with Section 405(b)

10 MS. WILLIAMS: He asked -- Mr. Jordan emailed  
11 the owner and also called, I think, two days prior to.

1 through a designated representative may result in  
2 denial of the license application or dismissal of a  
3 protest, unless, in the discretion of the Board, good  
4 cause is shown for failure to appear.

5 A request for reinstatement with the Board  
6 must be filed within ten days of the dismissal or  
7 denial date. So at this point it's denied, the  
8 application, and they will have to start the process  
9 again to file a motion for reinstatement.

10 MALE BOARD MEMBER: Motion.

11 CHAIRPERSON MILLER: Yeah, motion the Board  
12 for reinstatement. So -- and then exactly -- and then  
13 -- right.

14 I'm going to be presenting that to the Board  
15 as a motion to vote on and -- unless, Ms. Williams, do  
16 you have any -- do you have anything to say to that  
17 motion? Okay. Okay. The Board did not hear that the  
18 applicant was on the way or ask the Board to reschedule  
19 this hearing. So that's what I would move to deny,  
20 this application. So we
