BEYANE: Good morning. 7 CHAIRPERSON MILLER: And would you introduce 8 yourself for the record, please? 9 MS. BEYANE: My name is Abeba Beyane. I'm 10 the owner of Mood Lounge. 11 CHAIRPERSON MILLER: Okay. 12 MR. STERN: Michael Stern representing the 13 District of Columbia. 14 CHAIRPERSON MILLER: Okay. Ms. Beyane, this 15 is a show cause status hearing. So I need to ask you, 16 since you're the owner, did you receive notice of this 17 hearing? 18 MS. BEYANE: Yes, ma'am. 19 CHAIRPERSON MILLER: Okay. Did you read it? 20 MS. BEYANE: Yes, ma'am. 21 CHAIRPERSON MILLER: Did you understand it? 22 (No audible response.)	4	1 MS. BEYANE: Uh-huh. 2 CHAIRPERSON MILLER: Okay. Do Board members 3 have any questions on this offer in compromise? Okay. 4 Then I would move that we accept this offer in 5 compromise of a fine of \$3000 to be paid within 90 6 days, license suspended for one day on November 2nd, 7 2012. 8 Do I have a second? 9 MR. NOPHLIN: Second. 10 CHAIRPERSON MILLER: Mr. Nophlin has seconded 11 the motion. Any comments? 12 (No audible response.) 13 CHAIRPERSON MILLER: Okay. Then all those in 14 favor of the motion, say aye? 15 MR. ALBERTI: Ms. Miller, I believe Ms. 16 Beyane -- 17 MS. BEYANE: Yeah. 18 CHAIRPERSON MILLER: Oh, I'm sorry. 19 MR. ALBERTI: That's okay. 20 MS. BEYANE: November 7. 21 CHAIRPERSON MILLER: Seven? 22 MS. BEYANE: Yeah.
3	1 CHAIRPERSON MILLER: And do you waive the 2 Board's reading the notice into the record? Do you 3 waive the Board's reading the notice into the record? 4 MS. BEYANE: (Indicates yes) 5 CHAIRPERSON MILLER: Okay. Mr. Stern, are 6 there any preliminary matters in this case? 7 MR. STERN: Yes, there are. In this case the 8 parties have reached an agreement, which we hope the 9 Board will accept as an offer in compromise. The 10 respondent will pay a fine of \$3000 within 90 days. 11 And there will be a one-day suspension, which will be 12 served. We had -- the suspension will be served on 13 November 7th. 14 CHAIRPERSON MILLER: Ms. Beyane, I just want 15 to ask you if that's your understanding of an offer in 16 compromise that you agreed to, that being a fine of 17 \$3000 to be paid within 90 days and the license 18 suspended for one day on November 2nd. 19 MS. BEYANE: Uh-huh. 20 CHAIRPERSON MILLER: Okay. And you 21 understand that you waive your right to a hearing by 22 accepting an offer in compromise?	5	1 CHAIRPERSON MILLER: Okay. 2 MR. STERN: Yes, November 7th is the day we 3 were -- 4 CHAIRPERSON MILLER: Sorry. November 7th. 5 So the motion's amended to reflect that it's November 6 7th that the day -- is the day that the license will be 7 suspended. Okay. The motion's been seconded. All 8 those in favor, say aye? 9 (Chorus of ayes.) 10 CHAIRPERSON MILLER: All those opposed? 11 (No audible response.) 12 CHAIRPERSON MILLER: All those abstaining? 13 (No audible response.) 14 CHAIRPERSON MILLER: Then the motion passes 15 by a vote of 5-0-0. Okay. Thank you very much. 16 MS. BEYANE: Thank you. 17 (WHEREUPON, at 9:47 a.m., the hearing was 18 concluded.) 19 20 21 22
