Okay.</p> <p>4 And did you introduce yourself, sir?</p> <p>5 MR. PARK: My name is Chen Su Park (ph).</p> <p>6 CHAIRPERSON MILLER: Okay. All right. This</p> <p>7 is a show cause status hearing. So I need to ask the</p> <p>8 Licensee, did you receive notice of this hearing?</p> <p>9 MR. LEE: Yeah, we received the (inaudible) --</p> <p>10 CHAIRPERSON MILLER: Okay. Good.</p> <p>11 MR. Three thousand dollars would</p> <p>21 be paid within 60 days.</p> <p>22 BOARD MEMBER: Say it again, please.</p>	5
2	<p>1 MR. STERN: The \$3000 would be paid within 60</p> <p>2 days. The suspension would be one day served on</p> <p>3 October 9th, four days stayed for a period of one year.</p> <p>4 The second charge, which emanates from the same set of</p> <p>5 facts, would be dropped.</p> <p>6 CHAIRPERSON MILLER: Okay. So if I</p> <p>7 understand you correctly, the offer in compromise is</p> <p>8 for a fine of \$3000 to be paid within 60 days and</p> <p>9 license suspended for five days, four days stayed for a</p> <p>10 year, but pending no further violations, and then one</p> <p>11 day served on October 9th this year.</p> <p>12 MR. STERN: That's correct.</p> <p>13 MR. LEE: That's right.</p> <p>14 MS. OH: (Nodding head)</p> <p>15 CHAIRPERSON MILLER: Got it? Okay. And does</p> <p>16 the Licensee understand that by accepting this offer in</p> <p>17 compromise, he waives his right to a hearing?</p> <p>18 MS. OH: He said, "Yes."</p> <p>19 MR.
