COBURN: Hi there. 5 CHAIRPERSON MILLER: So this is the fact 6 finding for the Food Truck Festival. It is -- the 7 Licensee is Partners at 723 8th Street, S.E., trading 8 as The Ugly Mug, 723 8th Street, S.E., License No. 9 71793. Okay. I'm just going to take a second and look 10 at what was just passed to us. 11 MR. COBURN: That was our response to the 12 interrogative that (inaudible) asking for -- 13 CHAIRPERSON MILLER: Oh, the questions. 14 MR. COBURN: -- supplemental information to 15 the applicant. 16 CHAIRPERSON MILLER: Okay. Well, why don't 17 you start with introductions for the record? 18 MR. COBURN: Hi there. I am Skip Coburn. 19 I'm executive director of the DC Nightlife Association. 20 And the DC Food Truck Association asked me to please 21 help them process all of the applications and permits 22 for this event, including the ABC one-day substantial</p>	<p style="text-align: right;">4</p> <p>1 the event for us? 2 MR. COBURN: Okay. If you refer to the -- if 3 you open the site plan to the one -- 4 CHAIRPERSON MILLER: Watch those mikes again. 5 MR. COBURN: I just -- I'm sorry. 6 CHAIRPERSON MILLER: If we open up what? 7 MR. COBURN: If you open up the site plan, 8 which is the last page of the -- 9 CHAIRPERSON MILLER: Okay. 10 MR. COBURN: -- of that I just gave you -- 11 CHAIRPERSON MILLER: Yep. 12 MR. COBURN: -- what I'm saying will probably 13 relate best to the site plan. That's just the 14 questions. This is at Union Market. And there's a 15 large parking lot there at Union Market. You all have 16 previously approved events at this location. So I 17 think you're familiar with the huge parking lot there 18 between 5th and 6th, right off of Neal Street, which is 19 where the Union Market is in the Florida Market area. 20 CHAIRPERSON MILLER: Uh-huh. 21 MR. COBURN: We're using the same plan and 22 the operations that we used for the Brightest Young</p>

JABLONSKI: My name is Gaynor Jablonski. 4 I'm the managing -- 5 CHAIRPERSON MILLER: I'm sorry, I didn't 6 hear. 7 MR. JABLONSKI: My name is Gaynor Jablonski. 8 I'm the managing member for Partners at 723 8th Street, 9 S.E., LLC. 10 CHAIRPERSON MILLER: Okay. 11 MR. RATHBONE: My name is Patrick Rathbone 12 and I am representing the DC Food Truck Association. 13 I'm the owner/operator for The Big Cheese Food Truck 14 and the organizer for the association of the event. 15 CHAIRPERSON MILLER: Okay. 16 MR. GHENENE: And Abyie Ghenene, ABRA 17 investigator. 18 CHAIRPERSON MILLER: Okay. So Mr. Coburn, 19 are you going to -- you're going to be -- 20 MR. COBURN: Yes, ma'am. 21 CHAIRPERSON MILLER: -- answering most of the 22 questions? All right. Can -- do you want to describe</p>	<p style="text-align: right;">5</p> <p>1 Thing event that was there about a month ago, some 2 other type event, except that they were standing inside 3 the building and our event is totally outside the 4 building. 5 CHAIRPERSON MILLER: Okay. 6 MR. COBURN: The food trucks -- there's a 7 plan to have about 35 food trucks. This map you have 8 is to scale. It's reduced but it's to scale in ratio. 9 Each of the food trucks lined up around the perimeter 10 fence are -- that's in a 20-foot-by-8-foot square. 11 You can see that the emergency exits are also 20 feet 12 wide. And there's only one entrance there on Neal 13 Street. That's the only point of entry where there 14 will be a security post. And the one ID checking point 15 for everybody that enters the other exit over there on 16 the -- on the top of your chart is an emergency exit 17 for fire, egress or any other emergency. 18 So all of the alcohol control will be at one 19 point at that first aid/ID checkpoint tent at the left 20 of your map. There's going to be a single point of 21 sale for alcohol, the tent there that says, "Bar." 22 That is the only place alcohol will be sold. And the</p>

<p style="text-align: right;">6</p> <p>1 other two tents are for tables and chairs. There's 24 2 chairs in each -- projected for each tent. And there's 3 a small 10-by-10 stage for a DJ part of the time and a 4 small band the other -- some other hours. 5 And you'll see the porta-johns in the upper 6 right-hand corner, probably overkill but that's what we 7 signed up for, that number of porta-johns. Let's see. 8 It's a -- the event runs from about 10:00 or 11:00 a.m. 9 to 10:00 p.m. And the parking lot is lit. 10 It's a commercial parking lot so it's lit. The 11 perimeter has this fence around. It's eight feet tall 12 and it's a totally enclosed -- 13 CHAIRPERSON MILLER: Okay. 14 MR. COBURN: -- perimeter. So nobody's going 15 to go anywhere. And it's one of those chain-link 16 fences. So somebody would have trouble passing alcohol 17 to anybody outside. 18 MR. RATHBONE: And the trucks are going to be 19 lined up around that outside as well. 20 MR. COBURN: True. Okay. 21 CHAIRPERSON MILLER: Outside as well as 22 inside?</p>	<p style="text-align: right;">8</p> <p>1 happy to answer them. 2 CHAIRPERSON MILLER: Okay. Well, I do just 3 looking at your plan. So, I mean, there's a lot of 4 open space here. But everybody goes -- they get their 5 food from the food trucks and get their drinks from the 6 bar. And then they go in these tents to eat? 7 MR. COBURN: No. They -- it's designed more 8 or less just to mill around. And a lot of the food 9 that's sold at the food trucks is, you know, like, a 10 taco -- 11 CHAIRPERSON MILLER: Right. 12 MR. COBURN: -- you take around and eat it, 13 put this in this hand and drink in the other hand. And 14 so we hadn't anticipated a large need for a lot of 15 tables and chairs. We've projected, like, 24, 25, 26 16 seats in each of those tents for people who are elderly 17 or -- 18 CHAIRPERSON MILLER: Oh, okay. 19 MR. COBURN: -- or who want to sit down or 20 have kids or something. But it's mostly a stand-up- 21 and-walk- around event, especially because so many of 22 the food trucks, you know, are almost like amusements</p>
<p style="text-align: right;">7</p> <p>1 MR. RATHBONE: Not outside but along the 2 perimeter of the fence. 3 CHAIRPERSON MILLER: Oh, right. Exactly. 4 Okay. 5 MR. COBURN: They can see that on the chart. 6 MR. RATHBONE: Well, I'm just saying it's 7 very difficult to get outside the fence. 8 MR. COBURN: Okay. The food trucks all have 9 their own licenses, permits, health inspections, 10 everything. We've already got -- you know, as usual 11 with a special event, we've already gotten all the 12 special event approvals from fire, health and safety, 13 EOH, you know, the normal entities. You're actually -- 14 other than the final construction permit for these huge 15 20-by-20 tents -- it's amazing that DC requires us to 16 get a construction permit for every tent. 17 But other than getting the final construction 18 approval for the tent, we have all the other permits 19 except this one. I hope that's -- 20 CHAIRPERSON MILLER: So -- 21 MR. COBURN: -- my basic introduction. If 22 you have any other specific questions, I'm more than</p>	<p style="text-align: right;">9</p> <p>1 in themselves. You look up and you see all the signs 2 and order one little thing and another little thing 3 there. And so there wasn't anticipated -- 4 CHAIRPERSON MILLER: Oh, right. 5 MR. COBURN: -- a great need for tables and 6 chairs. 7 CHAIRPERSON MILLER: Okay. How many people 8 do you anticipate? 9 MR. COBURN: About -- around 200 or 250 10 people at any one time and hopefully, if the event is 11 successful, maybe a total of 2000 all day long. But 12 about 200, 250 people at any one time, we're thinking. 13 CHAIRPERSON MILLER: So will people not be -- 14 will people be stopped from coming in if it's too 15 crowded? 16 MR. COBURN: Oh, sure. But for the fire 17 department, we had to do an occupant load assessment. 18 CHAIRPERSON MILLER: Uh-huh. 19 MR. COBURN: And based on -- I -- you can see 20 the measurements here. It's huge. The standing 21 occupant load for the net square footage -- once you 22 subtract the area for the tents -- I'm very detail</p>

COBURN: -- square footage for the fire 5 department, I subtracted the area of the tents, the 6 area of the stage and a 20-foot border all the way 7 around the outside where the food trucks are. And the 8 standing occupant load is 13,000. So we're not going 9 to max out on occupant load. 10 CHAIRPERSON MILLER: Oh, okay. 11 MR. COBURN: It's -- 12 CHAIRPERSON MILLER: I just got a little 13 concerned -- confused. 14 MR. COBURN: Yeah, yeah. 15 CHAIRPERSON MILLER: When you said 250 at one 16 time, I thought -- 17 MR. COBURN: Yeah, no. Two fifty at one time -- 18 CHAIRPERSON MILLER: -- that sounded low. I 19 mean -- 20 MR. COBURN: -- is not even going to approach 21 the occupant load. 22 CHAIRPERSON MILLER: Okay.</p>	<p style="text-align: right;">12</p> <p>1 forever. So we rotate people in about every hour. We 2 have three security posts identified where that would 3 be a manned post. And then the other 12 people would 4 be roving security, just to see that everything's going 5 well. 6 CHAIRPERSON MILLER: Who's checking IDs? 7 MR. COBURN: The -- all the ID checkers are 8 from licensed ABC establishments and that's their 9 regular duty every night or every day. 10 CHAIRPERSON MILLER: Uh-huh. 11 MR. COBURN: Just so they've all been to 12 training and do this as a routine part of their job 13 every day. It's ABC establishment employees that do 14 this routinely. 15 CHAIRPERSON MILLER: Okay. Are they -- are 16 they going to use wrist bands or anything like that? 17 MR. COBURN: Yes. Yeah, we're going to use 18 different colored wrist bands to identify the people 19 that are 21 and over and the people who aren't 21. And 20 then the purpose of the -- actually part of the reason 21 for the roving people -- since this is a family event 22 and there'll be people of all ages, part of the</p>

It's 68,000 square feet -- is this parking 3 lot, when you subtract the 1300 square feet that I 4 subtracted from the net load. So they have plenty of 5 room for those 2000 people. 6 CHAIRPERSON MILLER: Okay. All right. But -- 7 MR. COBURN: The fire department made me do 8 that. I said, "You've got to be kidding." For Alan 9 Carroll (ph) at the fire department. 10 CHAIRPERSON MILLER: Okay. 11 MR. COBURN: He said, "You have to give me a 12 computation of the maximum occupant load for standing." 13 I said, "It's over 60,000 square feet and we're 14 projecting 2000 people. Are you kidding?" He says, "I 15 have to see it." So I had to do it. 16 CHAIRPERSON MILLER: Okay. So -- and how are 17 you controlling the alcohol? 18 MR. COBURN: On the chart there you can see 19 that we were projecting three permanent security posts. 20 And as -- sorry -- as you guys like, we indicated on 21 our -- on our questionnaire responses that we also 22 agree, you know, you can't have somebody standing there</p>	<p style="text-align: right;">13</p> <p>1 instructions that we've given for the roving security 2 people is that's what they're supposed to be -- one of 3 the things they're supposed to be looking for, is to 4 make sure that people who are 21 aren't handing 5 anything off to people who are under 21. 6 CHAIRPERSON MILLER: So everybody's going to 7 have a wrist band? They're just going to have 8 different colors? 9 MR. COBURN: That's my intent. Well, you 10 know, if they're 10, I don't think, you know -- in the 11 questionnaire I said, "Except children, whatever we 12 decide that is." I don't see a point in giving a wrist 13 band to a ten year old. 14 CHAIRPERSON MILLER: Right, right, right. 15 MR. COBURN: So there'll be some -- 16 CHAIRPERSON MILLER: Where it's really 17 obvious. 18 MR. COBURN: -- something there, yes. 19 CHAIRPERSON MILLER: Okay. So I just want to 20 get back -- I'm looking at your application, the front 21 page. Do you know the numbers again? Just, you know, 22 you say you expect 5000 to attend but only 500 at any</p>

Do y'all ever get 8 any after action reports on something like the 9 Brightest Young Thing event we had there a month, two 10 months ago? 11 CHAIRPERSON MILLER: I didn't. 12 MR. COBURN: Because they had projected -- 13 CHAIRPERSON MILLER: Yeah. 14 MR. COBURN: -- like, 4000 people and they 15 had, like, 600 because it rained all day. So you never 16 know. 17 CHAIRPERSON MILLER: Oh -- 18 MR. COBURN: You never know. 19 CHAIRPERSON MILLER: Okay. Okay. Right. 20 But you're prepared. All right. What kind of 21 entertainment is there going to be? 22 MR. COBURN: Why don't you talk about that?</p>	<p style="text-align: right;">16</p> <p>1 MR. JABLONSKI: So I don't know if that's a 2 certain age requirement on that. 3 MR. COBURN: Interestingly enough, I was just 4 told that, while we were standing in the hall, one of 5 those people who just RSVP'ed is Nick Midgette (ph). 6 CHAIRPERSON MILLER: Really? That's good. 7 Okay. 8 MR. COBURN: He's a food truck enthusiast, 9 apparently. 10 CHAIRPERSON MILLER: Okay. Let's see if I 11 have any other comments. What kind of alcohol are you 12 serving? 13 MR. JABLONSKI: There will be three different 14 types of beers. There will be four different pre-mixed 15 alcoholic drinks. There'll be an Orange Crush vodka- 16 based drink, a margarita, a sangria, and then a -- 17 like, a Lynchburg lemonade with -- not made with Jack 18 Daniels - - a bourbon drink. But they will all be pre- 19 mixed and pre-portioned and there won't be any free 20 pouring of alcohol. 21 And then there's going to be two types of 22 wines, a red and a white.</p>
<p style="text-align: right;">15</p> <p>1 MR. JABLONSKI: There'll be a DJ who will be 2 there to MC. And then we have three bands lined up. 3 MR. RATHBONE: Oh, there's a clown. 4 MR. JABLONSKI: Clown. 5 CHAIRPERSON MILLER: A clown? 6 MR. COBURN: We have a clown. 7 MR. JABLONSKI: And a clown. 8 MR. RATHBONE: And a clown. 9 CHAIRPERSON MILLER: What kind of bands? 10 MR. JABLONSKI: Two to three-piece bands 11 mostly playing rock and roll to alternate rock. 12 They've been booked out of a studio here locally. So 13 I'm not 100 percent sure of their type but they're 14 smaller groups that'll fit on the stage. 15 CHAIRPERSON MILLER: And are you gearing this 16 to -- I'm looking at your application now. It says 17 that you're gearing up to a certain age? No? 18 MR. JABLONSKI: I wouldn't say there's a 19 certain age we're gearing it towards. People who like 20 food trucks. 21 CHAIRPERSON MILLER: Food truck people. 22 Okay.</p>	<p style="text-align: right;">17</p> <p>1 CHAIRPERSON MILLER: And are you checking IDs 2 just once? I mean, you check IDs once. They get the 3 wrist bands and that's it or -- 4 MR. COBURN: Well, we -- no. What we've 5 agreed to in talking together is that everybody's ID 6 will be checked at the point of entry and everybody 7 will -- every appropriate person will be given a wrist 8 band one way or the other. And the bartenders, like 9 always, have the responsibility that, if they see 10 something that looks a little askew, to double-check. 11 CHAIRPERSON MILLER: Okay. 12 MR. JABLONSKI: I also have -- I have three 13 establishments in the city. So I'm actually going to 14 have four of my managers there, which are all ABC 15 managers, there to help run the event. So they're 16 going to be actually at the bar, serving drinks, but 17 also making sure that they're ID'ing. And then all the 18 other people that were doing our -- are bartenders of 19 mine that work at other places. So they know the drill 20 to check IDs. 21 CHAIRPERSON MILLER: And do you have a plan 22 if anyone gets sick or intoxicated?</p>

JABLONSKI: I'm also going to be bringing 19 a first aid kit to put behind the bar, just someone 20 walk -- you know, if there's a booboo. 21 CHAIRPERSON MILLER: So what other agencies 22 have you been before that have signed off?</p>	20
19	<p>1 MR. COBURN: Let me double-check. I have it 2 here. Tax and Revenue signed off. DOH -- Jacqueline 3 Coleman signed off at DOH. Lieutenant Egan signed off 4 for Emergency Medical Services. Corporations Division 5 signed off. I've already talked -- spoken with the 6 gentleman over at Health and Safety and he's approved 7 my Health and Safety plan. But we haven't gotten 8 together to have him sign in. And those are the only - 9 - and you all are the only agencies that were required. 10 MPD approved and said, "We don't -- we don't 11 have a concern." So they didn't sign it because 12 they're not -- they said, "We don't need to be 13 involved." 14 CHAIRPERSON MILLER: Oh, but you went to them 15 anyway? 16 MR. COBURN: Yeah, went to them. What 4 percentage of that? 5 MR. COBURN: That would be you. 6 MR. RATHBONE: We're doing a -- we're selling 7 raffle tickets. Because we're not charging at the door 8 to get in. 9 MR. So the actual alcohol -- the sodas 2 are going to come off of the food trucks. So they sell 3 cans. 4 MR. ALBERTI: So -- but they would only sell 5 cans? 6 MR. RATHBONE: Every single -- every single 7 food truck is selling their own beverages. The only 8 restriction we had -- well, other than they're not 9 selling alcohol, but all non-alcoholic beverages, they 10 only restriction they had was no glass bottles. So 11 they'll be cans of Pepsi, bottles of water. 12 MR. ALBERTI: But not glasses? 13 MR. RATHBONE: Not glass, no glasses. But, 14 yeah, so -- 15 MR. ALBERTI: But if someone sees a glass, 16 they assume it's alcohol? 17 MR. JABLONSKI: They're going to be plastic 18 cups. 19 MR. RATHBONE: Well, we're using -- we're 20 using paper cups. 21 MR. ALBERTI: That's what I meant -- what I 22 mean. Okay.</p>

So this is 15 of the normally trained 4 security staff that come from mostly his apparently 5 licensed ABC establishments. 6 MR. JABLONSKI: That's correct. 7 MR. COBURN: And if he has -- but it's all 8 security staff that that's their job these days at ABC- 9 licensed facilities. And actually we thought if -- I 10 told them 15 was plenty based on the projected load 11 that we're anticipating at any one time and the huge 12 expanse and one alcohol sale point. And -- 13 MR. ALBERTI: Okay. 14 MR. COBURN: -- I figured 15 was going to be 15 a lot. 16 CHAIRPERSON MILLER: Uh-huh. 17 MR. ALBERTI: How do I know what kind of 18 drink you have in your hand, whether it's soda or 19 alcohol? How do you distinguish -- how would -- how 20 would someone roving around -- 21 MR.
