**ORDER ON DISMISSAL OF APPLICATION TO RENEW LICENSE**

The Application filed by Jackie Lee, Inc., t/a Jackie Lee Lounge, for renewal of its Retailer's Class CN License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on April 18, 2011, in accordance with D.C. Official Code § 25-601 (2001).

On April 18, 2011, pursuant to Title 23 of the District of Columbia Municipal Regulations (23 DCMR) § 1602.3 (2004), the Board dismissed the Application due to the Applicant's failure to appear at the Roll Call Hearing. The Applicant is James E. Adkins, who died on September 10, 2010. On January 6, 2011, the Circuit Court for Pinellas County, Florida, issued Letters of Administration appointing Stacy Adkins as the single, personal representative of the estate of James E. Adkins. The Applicant may file a Request for Reinstatement within ten (10) days from the date of this Order.


