ORDER ON DISMISSAL OF APPLICATION

The Application filed by Lee's Mini Market, Inc., t/a Lee's Mini Market, for a Substantial Change for a class change from a Class B license to a Class A license, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on April 29, 2013, a Status Hearing on June 5, 2013, and a Protest Hearing on July 10, 2013, in accordance with D.C. Official Code § 25-601 (2001).

The Applicant failed to file a Protest Information Form (PIF) with the Alcoholic Beverage Regulation Administration (ABRA) seven days prior to the July 10, 2013, Protest Hearing and failed to serve the PIF on all parties, as required by the Board. The Board instructed all parties at the Protest Status Hearing held on June 5, 2013, to file the PIF or risk having their Application or Protest dismissed. *Transcript*, 6/5/13 at 7-8.

ORDER


