2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Are there parties
4 present in the matter of Millies and Al's? This
5 is Case #16-PRO-00031, Ballances Columbia
6 Restaurant, trading as Milles and Al's Ballances
7 Columbia, 224 18th Street Northwest, License
8 Alcoholic Beverage Regulation Administration-
9 00460. This is a Retailer Class CH License
10 Renewal. The protest issues are adverse impact
11 on peace, order and quiet. My name is LaVerne
12 Fletcher; I'm conducting the Roll Call Hearing as
13 the Board's Agent pursuant to D.C. Official Code
14 1601.2. Introductions please.

15 MR. GUTHRIE: Yes, Ted Guthrie for ANC
16 1C.

17 CHAIRPERSON FLETCHER: Mr. Guthrie, have
18 you been in communication with the applicant at
19 all?

20 MR. GUTHRIE: I haven't. This is a
21 strange case. The placards went up and then the
22 placards came down. The restaurant is not

1 operating, it's empty, and I was advised by
2 ABRA's legal counsel that the best thing to do
3 was protest and see how things shake out.

4 CHAIRPERSON FLETCHER: Yes, my
5 understanding is that their applying to put their
6 license in safekeeping, so for that reason, I'm
7 going to make a note that you appeared today
8 because the Board has not yet approved the
9 application for safekeeping, I am going to
10 dismiss the application for renewal, and if the
11 application for safekeeping gets approved, if the
12 application for safekeeping is approved then, of
13 course, we'll undo the protest. So, I am
14 granting standing to ANC 1C, Mr. Guthrie, and
15 dismissing the license renewal application.

16 MR. GUTHRIE: Great. Thank you very
17 much.

18 CHAIRPERSON FLETCHER: Thank you for
19 coming. The Roll Call Hearing is concluded.
