1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: The second case in
3 our calendar is Case No. 15-CMP-00700, Mesobe
4 Restaurant and Deli, License No. 81030.

5 Will the parties please approach.

6 All right. It's 9:44. This was
7 scheduled for 9:30. I will --

8 MR. RIVERO: Good morning, council --
9 board members. Fernando Rivero for the District
10 of Columbia standing in for Luis Philips. I've
11 been informed that there's representation for
12 this licensee, and that the legal representative
13 is on the way and is going to be about 45 minutes
14 late. I have just (inaudible).

15 CHAIRMAN ANDERSON: Well, I was going to
16 -- all right. I will move forward. I will
17 recall this case.

18 CHAIRMAN ANDERSON: All right. Mr.
19 Rivero, is the licensee for 15-CMP-00700 here,

1 CHAIRMAN ANDERSON: We are going to have

7 do is that we put on the record the next
8 scheduled date. Should circumstances make it
9 possible to recall the case, and the board is
10 here today and I'm here today, that's fine. I
11 have no problem with that, having the case
12 recalled. Otherwise, we'll just move forward to
13 the next date.

14 CHAIRMAN ANDERSON: All right.

15 Well, for Case No. 15-CMP-00700, Mesobe
16 Restaurant and Deli Market, License No. 81030,
17 this case was scheduled for a 9:30 status
18 hearing. We were told -- it's 10:12. The
19 attorney said that he would be 45 minutes late.
20 I think it's more than 45 minutes. This matter
21 is scheduled for a show cause hearing on April 6,
22 2016, at 3:30 p.m.

1 And if you're here, maybe we can do this
2 after our next hearing, but if not, we'll just
3 see you for the show cause hearing.

4 MR. RIVERO: Right. Or you'll see Ms.
5 Philips for the show cause.

6 CHAIRMAN ANDERSON: All right. Thank
7 you.

8 MR. RIVERO: Thank you.
