**ORDER VACATING CANCELLATION OF LICENSE AND
REINSTATING LICENSE**

Montserrat House, LLC, t/a Montserrat House Catering, located at 2018 9th Street, N.W., Washington, D.C., failed to pay the third year license fees for its Retailer's Class Caterer License. Specifically, it failed to pay the license fees for the period of 2012 to 2013 for its license by March 31, 2012, the deadline for all Retailer's Caterer licenses, despite being notified of the payment date.

On May 9, 2012, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2012-195 ordering the Licensee to cease and desist selling, serving, and permitting the consumption of alcoholic beverages on its property. *See Board Order No. 2012-195.* An ABRA Investigator served the Order to the Licensee.

The Board then issued Board Order No. 2012-271, dated June 13, 2012, which cancelled the Licensee's license. *See Board Order No. 2012-271.* ABRA mailed the Order to the Licensee and no returned mail was received by ABRA. Nonetheless, on June 14, 2012, the Licensee paid the license fees for the period of 2012 to 2013 and the late fee.


