ORDER GRANTING REQUEST FOR REINSTATEMENT

The Application filed by Zhou Hospitality, LLC, t/a Muse Nightclub and Lounge, for a renewal of its Retailer's Class CN License, having been protested, came before the Alcoholic Beverage Control Board ("Board") for a Roll Call Hearing on November 29, 2010, in accordance with D.C. Official Code § 25-601 (2001).

On November 29, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed the Application because the Applicant failed to appear at the Roll Call Hearing. The Applicant filed a request for


reinstatement with the Board indicating that there was a misunderstanding regarding the need to appear for the hearing, as the actual notice delivered by Alcoholic Beverage Regulation Administration (ABRA) advising of the protest and requiring the Applicant's appearance was not received until December 1, 2010. Upon consideration of this request to reinstate the Applicant, the Board finds good cause to reinstate the Application pursuant to 23 D.C.M.R. 1602.3.

ORDER

For these reasons, the Board does hereby, this 8th day of December, 2010, **REINSTATE** the Application filed by Zhou Hospitality, LLC, t/a Muse Nightclub and Lounge, for a renewal of its Retailer's Class CN License. 




