2 CHAIRPERSON ANDERSON: Do we have Case  
3 Number 15-CMP-01010, Newton Food Market, License Number  
4 94313? This is not your case? Mr. Shapiro, this is not  
5 your case?

21 say that we will move forward to the show cause date for  
22 this case. However, I do have a meeting to resolve the

1 case, and so we may be back to you on resolving both of  
2 them in a status hearing prior to the end of the month.

3 CHAIRPERSON ANDERSON: Okay. Thank you.

4 Well, this matter is scheduled for June 8th at 3:30.

5 And if it's not -- if it's not resolved, I mean I would  
6 ask the parties to work with the applicant to come up  
7 with a date that will work with his schedule because it  
8 appears that both dates he has had some other court  
9 appearance in court. And so hopefully the parties can  
10 work on a date that will work for the applicant -- I'm  
11 sorry -- for the licensee if he's unable to make it  
12 here. Okay. That's fine. Thank you.
