**ORDER ON WITHDRAWAL OF ROSA RANDJELOVICH AND ZIVORAD
RANDJELOVICH'S PROTEST AND ON DISMISSAL OF PROTEST OF THE
GROUP OF SIX INDIVIDUALS**

The Application filed by The Popal Group LLC, t/a Napoleon, for renewal of its Retailer's Class CR License, located at 1847 Columbia Road, N.W., was protested. The Roll Call Hearing was held on July 22, 2013.

Rosa Randjelovich and Zivorad Randjelovich, submitted correspondence dated July

19, 2013, indicating that they were withdrawing their protest as individual members of the Group of Six Individuals in this matter.

On July 22, 2013, pursuant to Title 23 of the District of Columbia Municipal Regulations (23 DCMR) § 1602.3, the Board dismissed the Group of Six Individuals because after the withdrawal of Mr. Randjelovich and Ms. Randjelovich's protest, the Group of Six Individuals no longer met the standing requirements under D.C. Official Code § 25-601(2).

The Group of Six Individuals may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.


ORDER




