**ORDER CANCELLING LICENSE**


On October 10, 2014, the Alcoholic Beverage Regulation Administration's (ABRA) Enforcement Division determined that Pines Restaurant, Inc., t/a Pines of Florence, has ceased operations.

On November 13, 2014, the ABRA's Licensing Division mailed via United States Postal Service (USPS) a written notice to the Licensee notifying the Licensee that if it is no longer in operations, the license must be surrendered to the Board for safekeeping or the license will be cancelled, pursuant to the District of Columbia Official Code § 25-791. ABRA mailed the notice to the Licensee at his address of record, but it was returned undeliverable to ABRA.

It is hereby **ORDERED** on this 14<sup>th</sup> day of January, 2015, that Pines Restaurant, Inc.'s License No. ABRA-021995 is **CANCELLED**. A copy of this Order shall be sent to the Licensee.



**ORDER CANCELLING LICENSE**


