2 STATUS

3 CHAIRPERSON ANDERSON: The next matter we
4 now move to our Show Cause Hearing (Status). The
5 first matter on this calendar is case #15-CMP-
6 00997, Sign of the Whale, license #85120. Will
7 the parties please approach and identify
8 themselves for the record?

9 MR. RIVERO: Good morning Board members,
10 Fernando Rivero for the District of Columbia.

11 MR. BRODERICK: Steven Broderick for the
12 DCR Association for Sign of the Whale.

13 CHAIRPERSON ANDERSON: And who are you,
14 sir?

15 MR. BRODERICK: I'm the general manager.

16 CHAIRPERSON ANDERSON: Now, does the
17 Board have some documentation saying that you are
18 authorized to --

19 MR. BRODERICK: Yes, I originally -- it
20 was a letter to Ms. Delgado at whatever part of
21 the process kicked this whole thing off, signed
22 by John Sullivan, he's our owner and licensee.

1 CHAIRPERSON ANDERSON: And you're Mr.
2 Broderick, right? Okay. The Board has the
3 requisite documentation. Mr. Rivero, are there
4 any preliminary matters in this case?

5 MR. RIVERO: No, there are not. The
6 government is ready to move to the next scheduled
7 date. In the meantime, the parties are working
8 on a settlement and the government is taking a
9 further review of its evidence and should there
10 be any settlement we would ask for a status
11 hearing, otherwise we will move to the date.

12 CHAIRPERSON ANDERSON: Okay, then this
13 matter is scheduled for a Show Cause Hearing on
14 August 3rd at 10:00. Thank you very much.

15 MR. RIVERO: Thank you.
