1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: I would like to
3 welcome you to the regularly scheduled meeting of the
4 District of Columbia Alcoholic Beverage Control Board.
5 Please know that today's hearings will be conducted in
6 accordance with D.C. official code Section 574 of the
7 Open Meetings Act. Today is May -- today is May 4,
8 2016.

9 I would like to introduce members of The
10 Board with us today. To my far right is Mr. -- is
11 Ms. Ruthanne Miller. To my far left is Mr. Mike
12 Silverstein, and to my immediate left is Mr. James
13 Short. My name is Donovan Anderson. I'm the Chairman
14 of the Board. The Board has four members in attendance
15 for the conduct of business today, and that constitutes
16 a quorum.

17 I would like to mention two things before we
