**ORDER GRANTING REQUEST FOR REINSTATEMENT**

The Application filed by GC Latino Productions, t/a Sabor Latino Bar & Grill, to renew its Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Regulation Administration (ABRA) for a Roll Call Hearing on July 12, 2010, in accordance with D.C. Official Code § 25-601 (2001).

On July 12, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed a Group of Five or More Individuals, represented by Fredia Banks, because one of the Protestants (Cliff Detric) failed to appear at the Roll Call Hearing. Subsequently, Fredia Banks, representing the Group of Five or More Individuals, filed a request for reinstatement with the Board. Upon consideration of the request to reinstate the Group of Five or More Individuals, the Board finds good cause to reinstate the Protestant pursuant to 23 D.C.M.R. 1602.3.


