ORDER ON DISMISSAL OF WENDY DEAN AND DENNIS DEAN'S PROTESTS

The Application filed by Food and Fun Network, LLC, t/a Slaviya, to amend its Entertainment Endorsement to include dancing for its Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on September 12, 2011, in accordance with D.C. Official Code § 25-601 (2001).

On September 12, 2011, pursuant to Title 23 of the District of Columbia Municipal Regulations (23 DCMR) § 1602.3 (2004), the Board dismissed the Protests of Wendy Dean and Dennis Dean for failure to appear at the Roll Call Hearing. Wendy Dean and Dennis Dean may file a Request for Reinstatement within ten (10) days from the date of this Order.






