**ORDER GRANTING APPLICANT'S REQUEST FOR REINSTATEMENT**

The Application filed by Indriani International, Inc., t/a Southeast Market, for renewal of its Retailer's Class B License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on December 12, 2011 and a Protest Status Hearing on January 25, 2012, in accordance with D.C. Official Code § 25-601 (2001).

On January 25, 2012, pursuant to Title 23 of the District of Columbia Municipal Regulations (23 DCMR) § 1602.3 (2004), the Board dismissed the Application, because the Applicant failed to appear at the Protest Status Hearing.

On January 26, 2012, Palitha Kalawane, Indriani International, Inc.'s owner, filed a request for reinstatement, indicating that he failed to attend the Protest Status Hearing, because he was sick with a backache and was unable to get out of bed.

ANC 6B did not oppose the Applicant's request for reinstatement.


### **ORDER**


