**ORDER DENYING REQUEST TO RE-PLACARD  
NOTICE OF APPLICATION**

An Application for renewal of a Retailer's Class CN License (Application) was filed by 1337 Conn. Coxtion, LLC, t/a Steve's Bar Room (Applicant) at premises 1337 Connecticut Avenue, N.W., Washington, D.C. The Notice of Public Hearing was posted on November 5, 2010 and lists the Petition Date as December 20, 2010, and the Hearing Date as January 3, 2011.

Will Stephens, Chairperson, on behalf of ANC 2B, contends in a letter, dated December 8, 2010, that the Applicant did not comply with the placarding requirements. The Alcoholic Beverage Control Board (Board) takes administrative notice that the Alcoholic Beverage Regulation Administration (ABRA) properly posted two placards at the Applicant's establishment on November 4, 2010, and the placards were still posted on December 17, 2010 during ABRA's second placard check. In addition, ABRA complied with all other notice

requirements. As such, the Board denies the ANC 2B's request to re-placard the Applicant's establishment.


### ORDER


