**ORDER TERMINATING VOLUNTARY AGREEMENT**

The Notice of the Petition to Terminate a Voluntary Agreement (Petition) filed by The Fab Lounge, Inc., t/a The Fab Lounge (Applicant), was posted on November 5, 2010, and the Petition Deadline was December 20, 2010. The Petition has not been protested.

The Applicant entered into a Voluntary Agreement with ANC 2B; ANC 2D; DCCA; and Marie Drissel, on behalf of A Group of Five or More Individuals, on February 15, 2005, which the Applicant now seeks to terminate under D.C. Code § 25-446(d)(4) (2004). *See* (ABRA Licensing File No. ABRA-070719). The Alcoholic Beverage Control Board (Board) finds that the Applicant has made a diligent effort to locate ANC 2B; ANC

2D; DCCA; and Marie Drissel, on behalf of A Group of Five or More Individuals, and made a good-faith attempt to an amendment to the Voluntary Agreement. *See* D.C. Code § 25-446(d)(4)(A)(i)-(ii) (2004). The Board also finds that terminating the Voluntary Agreement will not have an adverse impact on the community where the Applicant is located. *See* D.C. Code § 25-446(d)(4)(C).


Therefore, the Board approves the Petition filed by the Applicant.




