ORDER TO CEASE AND DESIST

The Alcoholic Beverage Control Board (Board) has determined that the Application for renewal filed by Beg Investments, LLC, t/a Twelve Restaurant & Lounge, located at 1123-1125 H Street, N.E., Washington, D.C., a Retailer's Class CT License, was protested by ANC 6A.

On December 11, 2013, a Protest Status Hearing was held and the Board dismissed the Application because the Licensee failed to appear at the Protest Status Hearing. *See* Board Order No. 213-605.

On December 17, 2013, the Applicant submitted a Request for Reinstatement and the Board denied the reinstatement of the Application on January 15, 2014. *See* Board Order No. 2014-028.

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Beg Investments, LLC, t/a Twelve Restaurant & Lounge did not submit a new Renewal Application.



Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 5th day of February, 2014, to **STOP selling, serving, or permitting the consumption of alcoholic beverages under your Retailer's Class CT License No. ABRA-076366**. You may not allow the sale of alcoholic beverages on the premises until your ABC License is reinstated by the Board.

A copy of this Order is being forwarded to the Metropolitan Police Department and D.C. licensed Wholesalers to ensure compliance. Failure to comply with this Order will subject the Respondent to the maximum civil penalties provided by the law.


