3 CHAIR MILLER: Okay. Next case, 15-  
4 AUD-00014, Zoo Bar Café, located at 3000  
5 Connecticut Avenue, NW, License Number 60391 in  
6 ANC 3C.

7 MR. RIVERO: Good morning, Board  
8 Members, Fernando Rivero for the District of  
9 Columbia.

10 CHAIR MILLER: Good morning. Good  
11 morning, sir.

12 MR. MCKINNEY: I am Stephen McKinney,  
13 President of Pub Management Incorporated, trading  
14 as Zoo Bar Café.

15 CHAIR MILLER: Okay. And did you  
16 receive notice of this hearing?

17 MR. MCKINNEY: Yes, I did.

18 CHAIR MILLER: All right. Did you  
19 read it and understand it?

20 MR. MCKINNEY: Yes, I did.

21 CHAIR MILLER: Okay. Then I  
22 understand there's no issue as to notice for this

1 hearing.

2 MR. MCKINNEY: No, there is none.

3 CHAIR MILLER: Okay. You can sign-in  
4 also if you haven't. Mr. Rivero, are there any  
5 preliminary issues?

6 MR. RIVERO: Yes, the parties have an  
7 offer-in-compromise to present to the Board at  
8 this time, and the offer is a fine of \$350,  
9 payable in 30 days, or the fine will be suspended  
10 until payment is received.

11 CHAIR MILLER: Okay. I want to ask  
12 you, sir, do you agree to this offer-in-  
13 compromise of a \$350 fine, payable within 30  
14 days, if it's not paid within 30 days, your  
15 license will be suspended?

16 MR. MCKINNEY: Yes, I do. I do accept  
17 that and I understand that.

18 CHAIR MILLER: Okay. And do you  
19 understand that you waive your rights to a  
20 hearing?

21 MR. MCKINNEY: Absolutely.

22 CHAIR MILLER: And you waive your

1 right to appeal. Okay. Any questions of the  
2 Board Members? All right. Then at this point, I  
3 move that we approve the offer-in-compromise of a  
4 fine of \$350, to be paid within 30 days. If not  
5 paid within 30 days, the license will be  
6 suspended.

7 MEMBER BROOKS: Second.

8 CHAIR MILLER: Okay. And Mr. Brooks  
9 has seconded the motion. All those in favor, say  
10 aye.

11 (Chorus of Ayes)

12 CHAIR MILLER: All those opposed? All  
13 those abstaining? Motion passes, 6-0-0. I  
14 should have asked this earlier, but what's the  
15 status of the quarterly statement? Has it been  
16 filed?

17 MR. MCKINNEY: It was filed. It was  
18 filed about three weeks late.

19 CHAIR MILLER: Okay. Good. Okay.  
20 Then you'll wait for this. Thank you.
