3 CHAIRPERSON MILLER: All right. We  
4 are going to now move then to the third case on  
5 the calendar, which is Case No. 14-CMP-00460,  
6 Georgia Line Convenience Store located at 5125  
7 Georgia Avenue, N.W., License No. 91196, in ANC-  
8 4D.

9 Are the parties here in this case?

10 Okay.

11 MEMBER ALBERTI: I think we are  
12 waiting for Ms. Phillips.

13 CHAIRPERSON MILLER: Could be, but I  
14 don't see anybody from Georgia Line either.

15 (Whereupon, the above-entitled matter  
16 went off the record at 9:56 a.m. and resumed at  
17 10:01 a.m.)

18 CHAIRPERSON MILLER: Okay. The next  
19 case that I had started to call was Case No. 14-  
20 CMP-00460, Georgia Line Convenience Store located  
21 at 5125 Georgia Avenue, N.W., License No. 91196,  
22 in ANC-4D.

1 MS. PHILLIPS: Good morning, Madam  
2 Chair. Louise Phillips for the Government.

3 CHAIRPERSON MILLER: Is anybody here  
4 from Georgia Line Convenience Store?

5 Not seeing anyone, we know that there  
6 are certain problems with Metro, etcetera.

7 MS. PHILLIPS: Terrific.

8 CHAIRPERSON MILLER: So what I'm going  
9 to do is schedule this for hearing, but if  
10 someone does appear from Georgia Line Convenience  
11 Store, we can recall the case if the parties  
12 would like us to.

13 So the Show Cause Hearing is scheduled  
14 for February 11, 2015 at 10:00 a.m. And my notes  
15 do show that Georgia Line was served with notice  
16 of this hearing on November 19, 2014.

17 MS. PHILLIPS: Thank you, Madam Chair.

18 CHAIRPERSON MILLER: Okay.

19 MEMBER SILVERSTEIN: Madam Chair?

20 CHAIRPERSON MILLER: Yes?

21 MEMBER SILVERSTEIN: For the record,  
22 we should note that there are problems and

1 backups on the Orange Line, Silver Line and Blue  
2 Line this morning because of a train that broke  
3 down at Stadium Armory and the resulting delays  
4 are 30 minutes or more.

5 And because of that and only because  
6 of that, we are extending the deadline for people  
7 who don't show, because it may be beyond their  
8 control. We are not doing this as a matter of  
9 fiat. We are doing it because it is a situation  
10 beyond anyone's control.

11 CHAIRPERSON MILLER: Okay.

12 MEMBER SILVERSTEIN: So if --

13 CHAIRPERSON MILLER: Thank you.

14 MEMBER SILVERSTEIN: -- someone were  
15 to be 45 minutes late on a day when we did not  
16 have a Metro problem, they would not have this  
17 leeway.

18 MS. PHILLIPS: It's a lucky break.

19 CHAIRPERSON MILLER: Okay.
