3 CHAIRPERSON MILLER: All right. So we  
4 will go back to the first case on the calendar,  
5 which is a Protest Hearing (Status) case, Case  
6 No. 14-PRO-00082, Good Hope Deli & Market located  
7 at 1736 Good Hope Road, S.E., License No. 93974,  
8 in ANC-8A.

9 Good morning. When you are ready if  
10 you could sign-in and introduce yourselves for  
11 the record?

12 MR. LEE: Good morning, Board Members.  
13 My name is Kevin Lee representing S & A Deli,  
14 Inc. t/a Good Hope Deli & Market. Next to me is  
15 the owner of the establishment.

16 MS. SNYDER: S & A Deli, Inc., owner  
17 Seres Snyder.

18 CHAIRPERSON MILLER: Good morning.

19 MS. CLARK: Good morning. My name is  
20 Barbara Clark, ANC-8A.

21 CHAIRPERSON MILLER: Okay. It seems  
22 like we just saw you.

1 MS. CLARK: Yes.

2 CHAIRPERSON MILLER: So I understand  
3 that this is the Protest Hearing for renewal of  
4 the B License. And is there any matters you wish  
5 to bring to our attention?

6 MS. CLARK: We do have -- well, I have  
7 presented them with a community agreement, but  
8 they haven't had a chance -- we haven't had a  
9 chance to get together with it and to put in or  
10 take out or whatever.

11 CHAIRPERSON MILLER: Okay.

12 MS. CLARK: So that's where we are  
13 standing right now.

14 CHAIRPERSON MILLER: Okay. All right.  
15 So you may reach an agreement in the meantime.  
16 I'm going to schedule you for the hearing in the  
17 event an agreement doesn't occur. And that  
18 hearing would be February 4, 2015 at 1:30 p.m.

19 And I know you all are familiar with  
20 the hearing and I just want to emphasize though  
21 the importance of the Protest Information Form  
22 and the Exhibit Forms which must be filed seven

1 days before the date of the hearing and served on  
2 opposing parties.

3 If we don't receive a copy of this  
4 Protest Information Form, your application or  
5 your protest may be dismissed. Hopefully that  
6 won't happen.

7 And if we don't receive a copy of the  
8 Exhibit Form and the exhibits themselves, your  
9 exhibits may be excluded from the record if there  
10 is a finding that the opposing party has been  
11 prejudiced and there has been no good cause for  
12 the failure to submit.

13 Likewise, you need to identify your  
14 witnesses, so there are no surprises at the  
15 hearing with respect to that.

16 You know, we have found that those  
17 forms and identifications have greatly assisted  
18 the Board in narrowing the protest issues and  
19 focusing on the issues at the hearing.

20 So if you have any concerns, you can  
21 contact Ms. Raines at 442-6492 or Ms. Jenkins,  
22 you're familiar with them, between now and the

1 hearing.

2 Okay. Do you have any questions?

3 MR. LEE: No.

4 CHAIRPERSON MILLER: Okay. Well,  
5 thank you very much.

6 MS. SNYDER: Thank you.

7 MR. LEE: Thank you.

8 CHAIRPERSON MILLER: Happy new year.

9 MS. CLARK: Happy new year to you all.

10 CHAIRPERSON MILLER: Thank you.
