3 CHAIRPERSON MILLER: All right. I
4 will call Case No. 14-CC-00082, WA-ZO-BIA located
5 at 618 T Street, N.W., License No. 79306, in ANC-
6 6E. Would the parties introduce themselves for
7 the record?

8 MS. PHILLIPS: Louise Phillips,
9 Assistant Attorney General for the District of
10 Columbia.

11 CHAIRPERSON MILLER: Okay. Is anybody
12 here from WA-ZO-BIA? Okay.

13 MS. PHILLIPS: My notes reflect that
14 the establishment was contacted yesterday and
15 there was no answer. And well, I have a service
16 form, but it doesn't say the date upon which it
17 was served or who served it. Maybe your file is
18 more up to date than mine.

19 CHAIRPERSON MILLER: I have in my
20 records that notice was served on November 19,
21 2014.

22 MS. PHILLIPS: I have here that it

1 says no fewer than three attempts were made and
2 they were closed: 11/22, 11/24 and 11/25.

3 CHAIRPERSON MILLER: Okay.

4 MS. PHILLIPS: And then it says, I
5 guess the initials are, DB on my service form.

6 CHAIRPERSON MILLER: Let me check.

7 MS. PHILLIPS: I can show the form
8 that I have, if you would like.

9 CHAIRPERSON MILLER: We are going to
10 check our records, as yours doesn't show that
11 there was actual service.

12 MS. PHILLIPS: Right.

13 CHAIRPERSON MILLER: So is that what
14 you said? Your form does not show the service?

15 MS. PHILLIPS: It does not show, but
16 it shows that they attempted it three times and
17 that all three times it was closed.

18 CHAIRPERSON MILLER: Oh, okay.

19 MS. PHILLIPS: And it was one time in
20 the p.m. and two times in the a.m.

21 CHAIRPERSON MILLER: Okay.

22 MEMBER ALBERTI: Since they are not

1 here, it seems like we can go ahead and schedule
2 the Show Cause and then address the service issue
3 in the interim.

4 MS. PHILLIPS: Perhaps. But when you
5 don't have service, they are not showing at the
6 status, they should not be penalized for it.

7 MEMBER ALBERTI: No, no, right, right.

8 CHAIRPERSON MILLER: Right.

9 MEMBER ALBERTI: And we would note
10 that, but we don't --

11 CHAIRPERSON MILLER: Okay.

12 MEMBER ALBERTI: -- really need to --

13 CHAIRPERSON MILLER: Okay. No, we are
14 not going to belabor this. Our form is similar
15 to yours, Ms. Phillips, so it does show the
16 attempts, but not the sign-off. So we can go
17 ahead and keep the date as of now, but we will
18 follow-up with the service issue in the interim.

19 The date as of now is February 4, 2015
20 at 10:00 a.m. Okay.

21 MS. PHILLIPS: Thank you, Madam Chair.

22 CHAIRPERSON MILLER: All right.
