4 is a second Armand's case and I'll call that  
5 now. It's 11-CMP-00273 with respect to  
6 License No. 75464.

7 MR. STERN: Good morning, Michael  
8 Stern representing the District of Columbia  
9 standing in for Louise Phillips, who is  
10 assigned to the case.

11 MR. PARK: Good morning, Sungwook  
12 Park, Vice President from Armand's Pizzeria  
13 location.

14 CHAIRPERSON MILLER: And could you  
15 repeat your name, please?

16 MR. PARK: Sungwook Park.

17 CHAIRPERSON MILLER: Okay. Are  
18 you vice president of the company?

19 MR. PARK: Yes, ma'am.

20 CHAIRPERSON MILLER: Okay. And  
21 did you receive Notice of Show Cause?

22 MR. PARK: Yes.

1 CHAIRPERSON MILLER: And did you  
2 read it?

3 MR. PARK: Um, he offer me 750.

4 MR. STERN: Have you read the  
5 notice?

6 MR. PARK: Oh, yes, yes.

7 MR. STERN: Did you understand it?

8 MR. PARK: Yes, I understand.

9 CHAIRPERSON MILLER: You  
10 understood it. Okay. There is a requirement  
11 that I read the notice unless you waive it, my  
12 reading it into the record. So do you waive  
13 my reading it into the record? Do you know  
14 what I'm saying?

15 MR. PARK: Yes. I read it and,

18 you waive the Chairman having to read this

10 that the establishment will pay a fine of \$750  
11 and we -- within two weeks, though we  
12 understand that they are able to pay it today  
13 to resolve these charges.

14 CHAIRPERSON MILLER: Okay. Mr.  
15 Park?

16 MR. PARK: Yes.

17 CHAIRPERSON MILLER: Do you agree  
18 to that?

19 MR. PARK: Yes, ma'am.

20 CHAIRPERSON MILLER: And could you  
21 -- can you articulate it, state it as well  
22 that what --

1 MR. PARK: Yes, I agree to pay  
2 \$750 for fine.

3 CHAIRPERSON MILLER: Okay. So you  
4 agree to pay \$750 fine within two weeks?

5 MR. PARK: Yes, ma'am, two weeks.

6 CHAIRPERSON MILLER: Okay. Board  
7 Members have any questions? Okay. Then I  
8 would move to accept that. I'm going to poll  
9 the Board.
