2 CHAIRMAN ANDERSON: The next matter on our show
3 cause hearing status -- hearing status is case number
4 15-CMP-00025, Desperados Pizza, license number 84731. Will
5 the parties please approach? Identify yourself for the
6 record, please.

7 MS. BOZKURT: Sahov Bozkurt, Owner.

8 CHAIRMAN ANDERSON: And there's also a sign-in
9 sheet to sign in too.

10 MS. PHILLIPS: Louise Phillips, Assistant
11 Attorney General for the District of Columbia again.

12 CHAIRMAN ANDERSON: Good morning again. Are
13 there any preliminary matters?

14 MS. PHILLIPS: Yes, Mr. Chair, there are. The
15 parties have spoken and agreed on an offer in compromise to
16 present to the board. It would be a \$650 fine paid within

6 accepting this offer in compromise that you're agreeing to
7 waive your right to a hearing?

8 MS. BOZKURT: Yes.

9 CHAIRMAN ANDERSON: And you're also agreeing to
10 waive your right to an appeal?

11 MS. BOZKURT: Yes.

12 CHAIRMAN ANDERSON: All right. Thank you.

13 Are there any board members who have any
14 questions regarding this offer in compromise?

15 (No response heard.)

16 CHAIRMAN ANDERSON: Hearing none, I make a motion
17 that this offer in compromise be accepted. Is there a
18 second?

19 MR. SILVERSTEIN: Second.

20 CHAIRMAN ANDERSON: Mr. Silverstein has seconded
