CHAIRPERSON MILLER: Okay, is anybody here from Smith and Wollensky? Smith and Wollensky? No. Okay. Cheesecake Factory. Is anybody here? Okay.

MS. SCHMIDT: Good morning.

CHAIRPERSON MILLER: Okay, wait. I'm calling Case Number 13-AUD-00030, Cheesecake Factory, located at 5345 Wisconsin Avenue NW, license number 14760, in ANC 3E.

Okay. Could you identify yourselves for the record, please?

MS. SALGUERO: Good morning. My name is Rosemarie Salguero, spelled S as in Sam, A-L-G-U-E-R-O, and I'm the attorney representative for The Cheesecake Factory.

CHAIRPERSON MILLER: Okay.

MS. GEPHARDT: And Chrissie Gephardt on behalf of the Office of the Attorney General for the District of Columbia.

CHAIRPERSON MILLER: Okay. And I

1 would note that this case is scheduled for a
2 show cause hearing this afternoon at 4:30
3 p.m., but I understand that you may have a
4 preliminary matter that would resolve the
5 case.

6 MS. GEPHARDT: Yes, we do have a
7 preliminary matter. In this case the parties
8 have agreed to settle the case for a fine of
9 \$2,000 for failure to file the quarterly
10 statement for the fourth quarter of 2012, and
11 that fine will be payable within seven days.

12 CHAIRPERSON MILLER: Okay, and
13 then I need to ask the licensee attorney, are
14 you agreeable to that fine of \$2,000 to be
15 paid within seven days?

16 MS. SALGUERO: Yes. Yes.

17 CHAIRPERSON MILLER: And you
18 understand you waive your right to a hearing
19 by entering into an offer in compromise?

20 (No audible response.)

21 CHAIRPERSON MILLER: Are there
22 Board questions?

1 MALE PARTICIPANT: None.

2 CHAIRPERSON MILLER: All right
3 then, I move that we approve this offer in
4 compromise of a \$2,000 fine to be paid within
5 seven days. Do I have a second?

6 MEMBER RODRIGUEZ: I second.

7 CHAIRPERSON MILLER: Mr. Rodriguez
8 has seconded the motion. All those in favor
9 say aye.

10 (Chorus of ayes)

11 CHAIRPERSON MILLER: All those
12 opposed?

13 MEMBER ALBERTI: No.

14 MEMBER BROOKS: No.

15 CHAIRPERSON MILLER: All those
16 abstaining? Okay, I believe the vote is 4-2-
17 0. Okay, if there's no question about that
18 then, with Mr. Alberti and Mr. Brooks
19 dissenting. Okay.

20 Okay, and if you'll just wait a
21 minute, we'll have to sign off on that.

22 So is there anyone here from Smith

1 and Wollensky? Okay. And I think that
2 concludes our show cause status hearings.
