CHAIR MILLER: Okay. The next case on the calendar is Case Number 11-CMP-00357, Zabb Asian Restaurant at 1836 18th Street, N.W., License Number 86253 operating in ANC 2B.

Good morning. Would you please introduce yourself for the record?

MR. RIVERO: Good morning, Board Members. Fernando Rivero for the District of Columbia.

MR. CHINSETTHAGIT: I'm Mongkhol Chinsetthagit and owner of the Kampai, LLC.

CHAIR MILLER: Okay. So, let me ask you. Did you receive the notice of the show case status hearing?

MR. CHINSETTHAGIT: Yes.

CHAIR MILLER: And did you read it?

MR. CHINSETTHAGIT: Yes.

CHAIR MILLER: Did you understand

2                   MR. CHINSETTHAGIT:   Yes.

3                   CHAIR MILLER:   Okay.   Mr. Rivero,  
4       are there any preliminary matters?

5                   MR. RIVERO:   Yes, Madam  
6       Chairperson.   The parties have an offer in  
7       compromise to present to the Board at this  
8       time.

9                   That offer consists of a fine of  
10       \$1,500 dollars payable in 30 days, \$1,250 goes  
11       to charge one and \$250 goes to charge two.

12                  CHAIR MILLER:   Okay.   And then I  
13       want to ask the Licensee, I want to repeat  
14       this and you tell me if that's your  
15       understanding and if you accept.

16                  It's a fine of \$1,500 payable  
17       within 30 days, \$1,200 goes to charge one and  
18       \$250 goes to charge two.

19                  MR. CHINSETTHAGIT:   One thousand  
20       two hundred and fifty go to charge one.

21                  CHAIR MILLER:   One thousand two  
22       hundred and fifty for charge one?

1 MR. CHINSETTHAGIT: Yes.

2 CHAIR MILLER: I'm sorry. Okay.  
3 One thousand two hundred and fifty for charge  
4 one and 250 for charge two?

5 MR. RIVERO: Correct. For a total  
6 of 1,500.

7 CHAIR MILLER: Okay. Payable  
8 within 30 days.

9 MR. RIVERO: Correct.

10 CHAIR MILLER: And you know that  
11 if you accept this you waive your right to a  
12 hearing?

13 MR. CHINSETTHAGIT: Yes, ma'am.

14 CHAIR MILLER: Okay. Okay. Board  
15 Members have heard the offer in compromise.  
16 I would move that we accept it.

17 MEMBER MOBLEY: I second, Madam  
18 Chair.

19 CHAIR MILLER: Okay. A fine of  
20 \$1500 payable in 30 days. Any comments?  
21 Okay. All those in favor say aye.

22 (Ayes.)

1 CHAIR MILLER: All those opposed.  
2 All those abstaining. All those opposed.  
3 Okay.

4 Then it passes 6 to 0 to accept  
5 your offer in compromise. Thank you.

7 hearing was adjourned.)
